In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

Unit D.3 puts in place an effective Common Agricultural Policy (CAP) by acting as partner to Greece, Italy, Cyprus, and Malta in preparing, implementing, monitoring and evaluating their CAP Strategic Plans for the 2023-2027 programming period. It also continues being a partner to the same countries for the closure of the rural development programmes (2014-2022 programming period), which was running until 2025.

Within its scope of activities, the unit contributes to the work on the implementation of the Recovery and Resilience Plans of the above member states and participates in the relevant inter-service working groups, including for the European Semester exercise.

The unit ensures follow-up of the implementation of the action plans for reducing error rates, where appropriate. Furthermore, it also contributes to networking, developing, and communicating the Common Agricultural Policy. The unit consists of 23 colleagues who contribute to a friendly and productive working atmosphere.

### WE PROPOSE

---

A contract of limited duration (1 year) for a position as programme assistant in the team of programme managers for the CAP Strategic Plan (2023-2027) and for the follow-up of the closure of the Rural Development Programme (2014-2022) of Greece.

This position combines autonomous work and collaboration with colleagues not only within the Unit, but also with other units in the DG, such as those dealing with policy, financial and legal matters, as well as with other Commission services. You will be in contact with the Member State authorities and other stakeholders and periodically you will provide advice on programme modifications.



Business travels to the Member States for the monitoring of committees and participation in annual review meetings are also part of the job.

## **WE LOOK FOR**

We are looking for a motivated colleague. Experience in agriculture/regional or territorial development or knowledge of Common Agriculture Policy issues would be an advantage.

The candidate should have good analytical aptitudes, excellent communication skills, and be able to assist in negotiating programme amendments with various stakeholders. S/he needs to possess good planning capacities and a strong team spirit. S/he should enjoy working with a high level of autonomy, but be open to exchanges, discussions and search of compromises, when needed.

As regards language competences, an excellent command of Greek and English is required.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

#### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language (Greek).

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG III**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

[For 3b] The duration of the **contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
