STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for International Partnerships (DG INTPA) contributes to sustainable development through international partnerships that uphold and promote European values and interests. DG INTPA's Directorate B is responsible for developing and implementing the international partnerships' agenda in Latin America, the Caribbean and with the Overseas Countries and Territories. Unit B.3 within Directorate B ('All Overseas Countries and Territories - OCTs) is in charge of the partnership established between 13 OCTs and the EU through the implementation of the Decision on the Overseas Association, including Greenland (DOAG). It coordinates the relations with OCTs, including political and policy dialogue, as well as programme management and implementation - in cooperation with relevant Commission's DGs and the EEAS, and in close consultation with three Member States to which OCTs are linked (Denmark, France, and the Netherlands).

WE PROPOSE

We propose a post for an enthusiastic and dynamic secretary in a friendly team composed of colleagues with different educational backgrounds.

The selected job holder would be given a broad range of secretarial and administrative responsibilities as well as a high degree of flexibility in the organisation of the work and the possibility to be fully associated to the various tasks of the unit. The main tasks are providing administrative support to the Unit and its management and to ensure that corporate business processes are followed up. This includes coordinating and monitoring actions and deadlines, organizing missions, events and meetings, managing and drafting documents, etc.

We offer a good opportunity to work in a fast-moving and stimulating working environment.



WE LOOK FOR

We are seeking a highly organised and proactive Administrative Agent to provide essential support to the Head of Unit and Deputy Head of Unit within DG INTPA.B.3, a team dedicated to international cooperation and development. This role demands a service-oriented professional with a strong administrative background and the ability to thrive in a fast-paced, multicultural environment.

This Administrative Agent role in DG INTPA.B.3 demands at least 2 years of hands-on administrative experience, including streamlining workflows, coordinating logistics (meetings, missions, and supplies), and ensuring compliance with EU procedures. Expertise in document and information management—using tools like ARES, MS Office (Excel, Word, Outlook), and EU-specific systems (DECIDE, MIPS, SYSPER)—is an asset. Full professional fluency in French and English (C1) is required, with additional EU languages a strong advantage. Experience in other areas such as communications, event management, budget tracking, procurement, or contract management (e.g., calls for tenders) would further strengthen your candidacy.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
