STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DIGIT B.1 provides digital services in the areas of data, artificial intelligence and web content management. The service offering of the unit includes foundational components, platforms, solutions delivery and procurement services for the digital transformation of the Commission and of its ICT domain.

The unit actively contributes to the implementation of the artificial intelligence strategy of the Commission and chairs the Interservice Steering Group on AI at operational level. Moreover, it plays a central role in the implementation of the data strategy of the organisation.

a team of skilled experts to implement the strategic vision for providing corporate digital services in the areas of data and artificial intelligence. The evolution of the Commission's Data Platform (ECDP) and the introduction of a corporate service on generative AI (GPT@EC) are integral parts of this vision.

The Head of Sector will formulate the technical vision, provide strong leadership, coordinate and contribute to the activities of the sector. She/he will develop the business case and the delivery model for the sector's services, whenever necessary, in cooperation with external contractors.

The mission of the 'Data and AI Operations' sector is to provide procurement services (Data and AI broker), advisory services (Data and AI competency centre), platform and product management services (including Business Intelligence), and solution delivery services for the areas of Data and Artificial Intelligence.

WE LOOK FOR

We are seeking a highly motivated, experienced, and business-minded Head of Sector with a mature sense of responsibility, the ability to lead a team of IT experts, and to manage multiple tasks simultaneously and autonomously. The successful candidate should have solid organisational, communication, and negotiation skills, along with a proven track record of managing IT projects/programmes following established methodologies, and IT operations in accordance with service level agreements.

He/She should be able to communicate complex concepts, prioritise urgencies, and handle crises in a resilient and efficient manner. A solid understanding of the importance of Data and Artificial Intelligence as drivers of the digital transformation of the Commission is essential. A good knowledge of Data and Artificial Intelligence policies, standards, and best practices is also an advantage. Oral and written command of English is essential.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^{\scriptscriptstyle 1}}$
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Luxembourg**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, in function group AD.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the 1^{st} contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
