## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

The unit is responsible and centre of knowledge for the various dimensions of the Multiannual Financial Framework (MFF), which is at the heart of all EU policies with budgetary impact and one of the most strategic and political file of the European Commission. The unit implements the MFF and NextGenerationEU, including long-term forecast of expenditures and revenues, sustainability of contingent liabilities, and steers policy innovations. The unit leads the preparations and negotiations of the MFF mid-term review and reflections on the future of the EU budget. Unit B1 is the economic cell of DG BUDGET, publishing "EU Budget Policy briefs" and steering the policy debate with the organisation of conferences and events. In performing these tasks, the unit has a key role in gathering and coordinating input from all Commission services.

### WE PROPOSE

---

A position at the centre of EU policy-making. A dynamic, challenging and rewarding work environment. Highly motivated, welcoming and friendly environment. An opportunity to build up a centre of knowledge within DG BUDG, actively contribute to the policy debate on issues related to the EU budget and NextGenerationEU. Interactions with a wide range of stakeholders inside and outside the Commission (in particular the European Council and the European Parliament but also external specialists). This is an opportunity to cover very different policy areas and domains of the Union's activities and get the big picture of what happens in the Commission and beyond; an opportunity to learn and grow in accordance with the needs of the job.

The successful candidate will work on quantitative simulation models on the MFF, the NextGenerationEU, on the revenue and expenditure side while at the same time s/he will contribute to the analysis and policy developments of the next MFF.

### WE LOOK FOR

We are looking for a dynamic and motivated colleague, with an economic, statistical or in data science background and with good quantitative skills to contribute to the design of EU budget for



the future.

The ideal candidate would have the following qualities :

- Experience in data management, budgetary and economic analysis (at least 1 year)
- Experience in dealing with the EU budget and EU spending programmes (at least 1 year)
- Experience in policy analysis and development (at least 1 year)
- Excellent drafting skills and communication skills and ability to disseminate the unit analysis via presentations, notes
- Strong interpersonal skills and ability to work as part of a team
- Ability to manage/coordinate different tasks and priorities at the same time while meeting extremely tight deadlines
- Flexibility and ability to adapt to changes in the tasks assigned.

The working language of the unit is English.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### ➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
