## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

# External Auditor

### WE ARE

---

Unit AGRI H.2 is responsible for the audit of market measures and rural development expenditure, managed and controlled by the Member States. In addition, the unit is in charge of carrying out conformity audits in Candidate Countries implementing IPARD (The instrument for pre-accession assistance for rural development programmes).

The main objective of our work is to provide the Commission with reasonable assurance that expenditure declared by paying agencies in the Member States and Candidate Countries has been incurred in compliance with EU rules. To meet this objective, compliance enquiries are carried out by way of audit missions. The amount of expenditure concerned is around 10 billion EUR per year. The Unit's other tasks include promoting effective and efficient control systems, assisting Member States and Candidate Countries in the proper interpretation and implementation of EU legislation, as well as participation in inter-service and inter-institutional exchanges on questions where the unit is competent.

### WE PROPOSE

---

The job involves preparing and carrying out audits in Member States and Candidate Countries in order to evaluate their management and control systems. The work involves drafting audit reports, organizing bilateral meetings the Member States and Candidate Countries authorities and propose imposing financial corrections, where necessary.

The number of audit missions to Member States and Candidate Countries is around 4 per year. Missions are generally of one week duration and usually start on Sunday.

The contradictory procedure with national authorities requires meeting strict deadlines.

### WE LOOK FOR

---

We are looking for an experienced auditor to join our Market Measures and IPARD team.

Candidates should have completed university studies relevant to audit (such as accounting,



controlling and audit) attested by a diploma. In depth knowledge of international audit standards is required.

The ideal applicant should have minimum 5 years of experience in audit.

The ideal applicants should demonstrate experience in carrying out system audits, preferably in public administration. The experience of audit in an international organisation would be an advantage.

Very good communication skills and drafting abilities in English are required. Knowledge of other EU languages, especially French, would be an advantage. Taking into account the work on IPARD, knowledge of languages of the Candidate Countries is a distinct asset.

The job requires strong analytical and organisational skills, excellent team spirit and ability to conduct audits independently respecting strict deadlines.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1<sup>st</sup> contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
