STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe.

Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Eurostat Unit F3 is one of the five units in Eurostat Directorate for Social Statistics and is in charge of the whole range of labour market and lifelong learning statistics. This covers collection, processing, dissemination and analysis of data as well as conceptual and methodological developments. Unit F3 comprises 28 persons and consists of five teams, of which three relate to the:

- (i) Labour Force Survey Production and Dissemination
- (ii) Labour Force Survey Main Indicators and Monthly Unemployment Rate
- (iii) Labour Force Survey Methodology and Analysis
- (iv) Lifelong Learning
- (v) Labour Market statistics on Businesses.

The wide range of data that F3 provides are key to economic, monetary and social policy. Our headline indicators get high attention by the media, financial markets as well as decision makers and are key elements of the European Pillar of Social Rights Dashboard. The Unit co-operates closely with users such as DG EMPL, EAC, ECFIN, JUST and REGIO of the European Commission as well as European Agencies (EIGE, ELA) and the European Central Bank, ILO, OECD and the UN.



WE PROPOSE

Unit ESTAT F.3 is seeking to hire a Statistical Officer/Data Scientist.

The position will consist of activities in the Labour Market statistics on Businesses (LMB) team and in the Labour Force Survey (LFS) Methodology and Analysis team. The LMB team deals with statistics on earnings (structure of earnings survey, gender pay gap, net earnings), labour costs (labour costs survey, labour cost index) and labour demand (job vacancy statistics). The structure of earnings and labour costs surveys are collected every four-years while job vacancy statistics and the labour cost index are quarterly. The LFS is the largest European social household survey and is quarterly. It contains microdata on labour status, employment characteristics, working time as well as education and training. The LFS methodology and analysis team deals with conceptual developments for the survey, definition of new variables, quality assessment, indicators development and analysing the data. It also develops and analyses complementary LFS annual modules on labour market subjects not covered by the core survey. The work is carried out in coordination with National Statistical Institutes and other national authorities as well as main users of LM statistics.

Under the supervision of the respective team leaders and in collaboration with members of the respective teams, the jobholder will be responsible for:

- 1) In the LMB domain:
- the quarterly production and dissemination of Job Vacancy Statistics
- the annual production and dissemination of net earnings.
- 2) In the LFS methodology and analysis domain:
- the development and implementation of annual modules (in 2024: development of module 2026 on digital platform employment and work for implementation of module 2025 on reconciliation of work and family life)
- the analysis of results of annual modules (in 2024: module 2023 on pension and labour market participation).
- 3) General support to other activities in both teams and participation in meetings with countries and users.

WE LOOK FOR

We are looking for a Statistical Officer/Data Scientist.

The ideal candidate for the job has at least a first experience in statistical production, dissemination or methodology, having analytical and organisational skills and who likes to work in a team. Service-mindedness, quick learning and a strong sense of responsibility are expected. A good command of English is essential. Knowledge and experience in statistical surveys and/or statistical IT packages for microdata processing and analysis would be an asset.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Oualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma. Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FII^1
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Luxembourg**.

In case the successful candidate is an external candidate, s/he will be engaged as a temporary agent under Article 2(b)/2(d) of the Conditions of Employment of Other Servants, in function group AD.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with Commission <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the 1st contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with Commission Decision C(2013)9049 on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.
