### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

The Unit E.3 - Transport, is part of the Directorate ESTAT.E - Sectoral and regional statistics and is responsible for the provision of transport statistics to support the European Union transport and mobility policies. The Unit is the leading provider of high-quality data on the transport of freight and passengers as well as on transport safety, transport infrastructure, and equipment. Transport statistics are collected for each transport mode (road, rail, aviation, maritime, inland waterways) based on statistical legal bases and agreements with reporting countries, EU Agencies and international organisations (UNECE, ITF). Annual, quarterly, and monthly statistics are published at national and regional level to monitoring policy initiatives under the European Green Deal, such as the Sustainable and Smart Mobility strategy, Safe, Sustainable and Connected transport, Fit for 55 initiatives, etc. The Unit is also developing methodologies for new transport statistics on modal split indicators, light utility vehicles, inland waterways passengers and the use of innovative data sources for traffic and mobility indicators.

#### **WE PROPOSE**

Unit ESTAT.E.3 is seeking to hire one economist or statistician.

The position will consists of managing one or several statistical production processes of the Unit. He/She will be responsible for collecting, validating, analysing and disseminating transport statistics in collaboration with other members of the Unit's team and external contractors. These activities require regular use of the Unit's informatics tools (Transport Information System and GSAST), preparation of publications, contacts with users and Member States, relevant Commission services and international organisations. He/she will also be involved in contract management and the organisation of Working Groups.



### **WE LOOK FOR**

We are looking for an economist or statistician with preferably at least two years of relevant professional experience.

We are looking for a highly motivated colleague with a positive attitude and a strong sense of responsibility and initiative.

The successful candidate should have the following competences and skills:

- service-mindedness, commitment, flexibility and a strong sense of responsibility;
- good analytical capabilities;
- excellent team spirit.

In addition, the successful candidate should have good oral and written command of English.

# 1. Selection

# > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Oualifications:**

In order to be recruited in this position, you must have at least either a level of post-secondary education attested by a diploma, <u>or</u> a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

## Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

# What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

### 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

### Type of contract and working conditions

The place of employment will be in **Luxembourg**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary** agent under Article 2(b) of the <u>Conditions of Employment of Other Servants</u>, in function group AST.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
