STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit AGRI.G.4 "Neighbourhood, enlargement and pre-accession assistance" promotes the EU's interests and position on agriculture in bilateral trade relations with the countries of the European Neighbourhood Policy, Central Asia and the Middle East, members of the European Free Trade Association, enlargement countries and other non-EU European countries.

The unit also assists candidate countries in the EU accession process aligning to the Common Agricultural Policy and in the implementation of the pre-accession assistance for rural development – IPARD programmes.

WE PROPOSE

Unit G.4 of DG AGRI is seeking to hire one contractual agent, who will contribute to the successful implementation of the newly agreed Ukraine Facility (Regulation (EU) 2024/792), providing predictable financial support for Ukraine over the period 2024-2027. In particular, we propose an interesting and challenging job as a programme officer who will contribute to the unit's work on the implementation of the Ukraine Plan as regards support for agriculture and rural development in Ukraine.

The successful applicant will also contribute to the preparations for Ukraine's process of accession to the European Union, by providing assistance and support to the gradual alignment of Ukraine to the EU acquis in the area of agriculture and rural development.

We offer a job involving regular contacts with various services of the European Commission, the EU Delegation in Kyiv and of course the Ukrainian authorities. The successful candidate will be warmly welcomed in our unit where we work very much in a pragmatic, collegial and pleasant atmosphere.



WE LOOK FOR

We are looking for a well-organised, dynamic and highly motivated team player, with extensive experience in agriculture and rural development matters and a solid understanding of the EU acquis in this area.

The ideal candidate will also preferably have relevant experience in the field of multi-annual programming and implementation of EU assistance, preferably in the area of agriculture and rural development. Experience in EU enlargement process would be an asset. The candidate will have a university degree, preferably in agronomics or economics.

The job requires a very good sense of organisation, analytical capacity, flexibility, reliability and the capacity to bring files forward in respect of deadlines. It requires also very good drafting and communication skills. Our new colleague should also have a good capacity to analyse and structure information, conceptualise problems, identify and implement solutions in a timely manner. A very good knowledge of English is essential (oral and written).

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

• have a thorough knowledge (minimum level C1) of one of the 24 official languages of the ${\rm FII}^1$

• AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG IV. General information on
Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with $\underline{\text{Commission Decision}}$ $\underline{\text{C(2017)6760}}$ laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year.** Subject to the interest of the service, the contract can be renewed, with a maximum duration until the end of 2027.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
