STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the PMO (Paymaster Office or Office for the administration and payment of individual entitlements) is to provide a high-quality and user-friendly service to beneficiaries by promptly and accurately managing, determining and paying individual rights and expenses (e.g., salaries, pensions, sickness insurance reimbursements and mission expenses).

The PMO.5 unit, located in Luxembourg and Brussels, includes 3 sectors: Settlements office - Luxembourg (001), Travel management (002), Laissez-Passer and Visas (003). The vacant post to be filled is in the Sector of Reimbursement of Travel Expenses in Brussels (002). This sector includes about 40 dynamic people.

WE PROPOSE

We propose a Contract Agent FG III position as an Administrative Assistant working under the supervision of an official or a temporary agent, the Administrative Assistant will:

- Provide administrative (encoding, regulations) and financial support to DG staff;
- Advise mission officers, line managers and authorising officers of the DG on the organisation of missions and authorised travel;
- Create and manage visa chains as required by the DG;
- Check mission orders/authorised travel orders and declarations of expenses against the rules, before
 approval by the authorising officer;
- Manage and monitor the budget allocations for missions in MIPS (IT tool for management of missions details, costs and spending);
- Prepare and disseminate reports and statistics on missions;
- Provide DG staff with all information on the rules, procedures and use of mission-related IT tools (MIPS, Online Booking Tool);
- Organise training and coaching on the rules governing missions and authorised travel;
- Participate in sector and unit meetings, and assisting direct superiors and heads of sector;
- Carry out ex ante controls on mission files and make proposal on improvement;
- Draft procedures to harmonize/clarify issues on mission files.
- Being the point contact/ coordinator between the Luxembourg and Brussels teams

WE LOOK FOR

This publication aims to fill 1 position.

We are looking for a dynamic and motivated colleague. The ideal candidate will be required to provide customer service with due regard for confidentiality. A sense of teamwork and collaboration is also essential. The ideal profile for the job has:

- good knowledge of the rules on administrative and budgetary management;
- Good understanding of and/or willingness to learn quickly the internal control rules;
- good organisational and planning skills;
- ability to provide excellent customer service;
- proven ability to take initiatives and propose pragmatic solutions;
- at least two years of job-related experience
- good ability to communicate clearly and in a structured manner both orally and in writing;
- ability to work under pressure;
- flexibility and openness with regard to new requirements, procedures, technologies.

The candidates are susceptible when needed by the service to provide support to other Sectors. Due to the large number of applications we receive, only pre-selected candidates will be notified. The pre-selected candidates will be invited to an interview and written test soon after the closing date for application.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

• have a thorough knowledge (minimum level C1) of one of the 24 official languages of the ${\rm FU^1}$

• AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on
Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> <u>C(2017)6760</u> laying down the criteria applicable to classification in step on engagement.

For contract agents under Article 3(a) the first contract will be 1 year. The contract might be extended in the interest of the service. If a second extension of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
