STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The audit Directorate of DG AGRI is responsible for obtaining assurance on the Common Agricultural Policy (CAP) expenditure, including by auditing the Member States' implementation of the CAP. Unit H.3 is one of the 4 audit units of the Directorate, and is responsible for the audit of (area- and animal-based) direct payments, rural development and eco-schemes managed and controlled by the Member States under the Integrated Administration and Control System (IACS), as well as conditionality.

The audit objective of the Unit is to provide the Commission with reasonable assurance that Member States' governance systems comply with EU rules and that their annual performance reports are reliable. To meet this objective, compliance audits are carried out by means of on-the-spot checks, desk audits and subsequent bilateral exchanges with Member State authorities. The Unit's other important tasks include promoting effective and efficient control systems, assessing regulatory proposals, assisting Member States in interpreting and implementing the rules correctly, and participating in inter-service and inter-institutional exchanges on questions where the unit is competent.

We are a unit of 27 people, work in teams and have a professional and open approach to our work.

WE PROPOSE

We have a vacancy in the team "Audit I" responsible for Ireland, Spain, Portugal, Bulgaria, Czechia, Hungary, Poland, Romania, Slovakia, Germany, Croatia, Austria and Slovenia.

The jobholder's core task is to plan and carry out assurance and audit work in Member States and to manage the subsequent conformity procedure, either as lead auditor or as audit team member. The number of audit missions averages 4 per year; they usually last one week and may require leaving on Sunday. Missions involve both office work and field visits to MS authorities, including national audit bodies.

The job implies frequent contacts with representatives from the 27 Member States and requires the jobholder, among others, to contribute to inter-service consultations, to do legislative drafting and to participate in meetings. Our audits are not inspections and do not concern the legality and regularity of subsidies or the financial accounts. Instead, we deal with Member States' governance systems underpinning the CAP implementation. We consider that the diversity of these topics, which are often news headlines, constitutes a rewarding challenge.

WE LOOK FOR

A dynamic, open-minded and flexible team player. While teamwork is essential, the successful candidate will also be called upon to work independently, developing and defending his/her positions in meetings with the management, the Member States and various boards and Institutions.

Major assets are therefore: analytical and synthetic skills, communication and drafting (language) skills. Although knowledge of the Common Agricultural Policy or other EU shared management policies and/or previous audit, control or equivalent legal experience are advantages, we aim at maintaining a diverse team with different backgrounds and experiences.

Simply put, this audit team is a nice and interesting place to be.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

² Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
