## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The Legal Issues & Enforcement Unit of DG MOVE is a coordination unit providing comprehensive legal assistance to DG MOVE sectoral units in all fields of transport. The unit contributes to ensure a harmonized and consistent preparation, negotiation, implementation and enforcement of EU transport policy and EU law, including on passenger rights legislation. The unit is the DG MOVE contact point with the Legal Service on all transport related issues.

The unit also coordinates the infringements policy of DG MOVE in close cooperation with SG. It monitors the implementation of DG MOVE acquis (pre-infringement and infringement cases), including complaint management, in a way that promotes the priorities of the Commission and enhances its partnership with Member States.

The unit is also responsible for the coordination of all public service obligations issues in all transport modes, in particular those relevant for land transport.

In addition, it coordinates competition issues within the DG as well as DG MOVE's position regarding the revision of competition instruments in particular in implementing the Smart and Sustainable Mobility Strategy.

Finally, it coordinates the access to documents files from an administrative and legal perspective.

### WE PROPOSE

---

She/he will provide legal advice to sectoral units of DG MOVE in one or several policy areas under the responsibility of the Directorate General, including on passenger rights. This can include, for instance, drafting/reviewing legal documents and legislative proposals, drafting legal consultations to hierarchy and Legal Service, providing legal assistance in meetings of sectoral units or of the hierarchy inside the Commission or with external parties as well as liaising with the Commission's



Legal Service on policy issues of her/his competence. She/he will provide legal advice on the substance and procedural elements of infringement procedures.

The position involves daily cooperation with sectoral units of the DG and other Commission services, in particular Legal Service and Secretariat-General.

## **WE LOOK FOR**

---

A highly motivated Legal Officer with a service-oriented spirit, a good pragmatic and problem-solving attitude as well as a good political judgment.

The ideal candidate should have a robust experience in the application of EU law in the transport area (transport policies/legislation and legislative procedures), including with passenger rights legislation and with infringements.

The successful candidate should have very good drafting skills in English and solid negotiating and communication capabilities (oral and written). He/she should have the capacity of explaining complex legal issues in a plain, straightforward language.

A good knowledge of two EU officials' languages, one of which should be English, is required.

Team spirit, communication skills and ability to adapt quickly to a changing working environment are essential.

The capacity to work independently as part of a team of legal experts is key to fulfilling the requirements of this post.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1<sup>st</sup> contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
