### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### **WE ARE**

Unit K3 is part of the Foreign Subsidies Directorate of DG Competition and is working with units K1 and K2, as a single team, in charge of the enforcement of the Foreign Subsidies Regulation. Its task is to identify and assess whether subsidies granted by non-EU countries are distorting competition in the EU internal market. We are a highly motivated team of colleagues who are enthusiastic to put into action this Commission competence.

#### **WE PROPOSE**

We are offering a position of new member in the foreign subsidies team. We are a team of colleagues who are responsible to put in place the implementation of the Foreign Subsidies Regulation which is at the intersection of EU's competition and trade policy. Due to the novelty of the legal framework, the work requires creative and pragmatic thinking in combination with a sound analytical and conceptual approach. The new colleague will be involved in preparing the implementation and dealing with cases and policy. The work requires a solid economic assessment capacity of the role of subsidies in companies and economies, coupled with an understanding of their legal aspects in light of the Foreign Subsidies Regulation. The precise scope of the work will depend on the needs of the directorate, the skills of the colleague, for example in terms of educational and professional background and sectorial experience, and his/her interests.

The directorate has a friendly and stimulating working atmosphere with management and colleagues who pay attention to human relationships. We encourage discussions and exchange of opinions and experience. Colleagues are given a high degree of autonomy in carrying out their tasks.



### **WE LOOK FOR**

We are looking for a motivated and dynamic colleague with a solid background in financial analysis, corporate finance and / or accounting. Knowledge of or practical experience in the enforcement of trade or competition law would be an asset. S/he needs to be proactive, diligent, responsible and flexible to work on cases and concepts in a holistic way involving different economic and legal aspects. Moreover, the new colleague should have a strong sense of teamwork to cooperate within the directorate team, across DG COMP as well as with other Commission services such as the Legal Service. The main working language of the taskforce is English, but knowledge of other EU or non-EU languages would be an advantage.

# 1. Selection

# > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

### **Qualifications:**

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

# Languages:

ullet have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $EU^1$ 

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

# What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

### Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> Decision C(2013)8970 laying down the criteria applicable to classification in step on engagement.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
