STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Mobility and Transport (DG MOVE) is responsible for developing transport and mobility policies for the European Union. Within DG MOVE, Unit 01 is in charge of ensuring strategic coherence in the DG's communication (externally and internally) and in its human resources policy.

WE PROPOSE

We propose a position of Press and Communication Officer within our communication team. You will be responsible for providing the Commissioner, other members of the College and the Director-General of DG MOVE with high-quality speeches for delivery to a range of audiences at a variety of events. You will also produce other communication materials such as scripts for video messages, blogs and articles. You will contribute to the design and delivery of the political narrative and strategy for DG MOVE.

This will include the following tasks:

- contributing to the development and planning of DG MOVE's external communications strategy and actions
- preparation / revision of speeches, including video messages
- preparation of media files for interviews/press conferences
- preparation of op-eds/editorials/interviews
- preparation of high-quality communication material on the Commission's transport policy
- contribute to news articles, press releases and other communication materials
- edit texts for clarity, conciseness, linguistic and grammatical accuracy, and audience
- liaising with SPP.



WE LOOK FOR

We are looking for a colleague who can communicate complex and often technical issues in an understandable and accurate manner. Suitable candidate should also have strong analytical and drafting skills, be creative as well as be able to quickly grasp general policy issues. S/he should be able to work quickly and under pressure, as well as to plan, prioritise and organise as requests evolve.

Experience in communication, good understanding of EU transport policy, as well as excellent drafting skills in English are essential. Above all we are looking for a team player who is at ease with colleagues at different levels of the hierarchy in and outside the DG!

A good knowledge of two EU official languages, one of which should be excellent English, is required. Knowledge of French and other EU languages would be an asset.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^{\scriptscriptstyle 1}}$
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the 1^{st} contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
