# STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

The mission of Unit D.1, Maritime Transport and Logistics is to develop a well-functioning and open market for sustainable maritime transport services and to promote multimodal freight transport and digital technologies.

Our responsibilities include:

• Developing and implementing policies promoting the use of sustainable maritime fuels, including through the European Sustainable Shipping Forum (ESSF).

• Enforcing EU legislation on the freedom to provide maritime transport services; including via international trade negotiations.

• Promote intermodal transport and sustainable logistics and the use of electronic transport documents in all modes of transport.

• Develop a reference framework on carbon footprint measurement in multimodal chains.

The Unit currently consists of 19 persons, including 1 trainee.

### WE PROPOSE

We propose an interesting and challenging job in a busy and dynamic unit with professional and friendly colleagues.

The position provides an opportunity to contribute to the green transition of the maritime transport and logistics, in the EU and globally. The job in principle involves work on sustainable shipping policies, including the implementation of new FuelEU Maritime Regulation (part of the Fit for 55 Package) in cooperation with Member States and the European Sustainable Shipping Forum. In addition, the post includes coordination of the maritime roundtable of the Renewable and Low-Carbon Fuels Value Chain Industrial Alliance and shipping related contributions to EU research agenda and sustainable finance policies.



The work will require daily cooperation with other DG MOVE units in the Maritime Directorate and beyond, as well as other DGs and the European Maritime Safety Agency. Frequent interactions with stakeholders in technical and policy dialogues, participation and speaking at external and internal events, drafting policy papers, legal texts and briefings are also part of the job. The tasks will include contract management.

### WE LOOK FOR

Given the technical nature of the file, the suitable candidate should have a solid engineering background and extensive experience in different energy conversion systems and innovative technologies in maritime transport. She/He should have excellent drafting and communication skills combined with an ability to structure and present complex topics to different audiences. Experience in contract management, as well in organizing the work of expert groups and ability to engage with stakeholders is also essential.

The ideal candidate would have experience in interinstitutional negotiations and coordination of transport and energy policies. She/he would be familiar with EU research programs and sustainable finance principles.

We are looking for a team player with a strong sense of initiative, very good inter-personal skills and networking/negotiation capabilities. She/He should be able to work independently, also under time constraints and pressure.

A good knowledge of two EU official languages, one of which should be English, is required; good knowledge of French would be an advantage.

# 1. Selection

# > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

## General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

### Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $\ensuremath{\text{EU}^{\scriptscriptstyle 1}}$
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

# > What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

# 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

# > Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, in function group AD.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the  $1^{st}$  contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
