STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit A4 is responsible for international affairs in the Directorate General for Financial Stability, Financial Services and Capital Markets Union (DG FISMA). The mission of the Unit is to develop, coordinate and implement the international strategy of DG FISMA, across all its instruments, to achieve the policy priorities of the DG and the Commission, particularly in relation to financial stability, sustainable and digital finance. The Unit is responsible in particular for the international activities related to sustainable finance. It coordinates and supports multilateral work in the G20, Financial Stability Board (FSB) and other international bodies, formulates FISMA's policy on the relations with third countries, runs bilateral regulatory dialogues with third country jurisdictions, including the United States, the UK, China, Japan, Canada. The Unit also contributes to EU trade, neighbourhood and enlargement policies and coordinates FISMA's actions in relation to Ukraine. The unit works closely with other units in the DG and with other DGs (e.g. DG ECFIN, DG TRADE, DG INTPA, DG NEAR) as well as the EEAS.

WE PROPOSE

Unit FISMA.A4 is seeking to hire a policy officer eager to work on the international aspects of financial services policies.

The new colleague will be expected to:

- provide input and advice for the formulation of DG FISMA's international strategy and prepare the participation in international multilateral organisations and fora;
- advise and coordinate DG FISMA position in G20 (financial regulation part) and FSB (Financial Stability Board) meetings and other relevant international meetings;
- organise and coordinate DG's bilateral cooperation with third countries;
- prepare analysis, and briefings on international aspects of financial markets and services, attend meetings and ensure follow-up;
- engage with stakeholders to explain the international activities of DG FISMA and seek their input in conferences, working groups, etc.



WE LOOK FOR

We are looking for a highly motivated colleague with a strong background in finance, an extensive knowledge of financial services policies, and good understanding of the functioning of financial markets and experience in the field.

Experience in coordination and international cooperation in the field of financial services is also required. The candidate must have a minimum of 10 years of professional experience in those areas.

The successful candidate must have highly developed analytical, drafting and communication skills. A very good knowledge of English is essential.

The candidate must have a strong team spirit, sound judgment and ability to work under time pressure.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in Brussels.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
