## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

Unit C.2 is responsible for the development and the implementation of a common EU policy on legal migration and for supporting and coordinating Member States' policies in the area of integration of third-country nationals. The Unit is also responsible for coordinating and promoting, including through financial incentives, the EU approach on resettlement, humanitarian admission and complementary pathways for people in need of protection, an area of increasing political importance in light of the current global context. In the field of legal migration, in particular, we are responsible for monitoring the implementation of seven Directives, covering the admission and the rights of different categories of third-country nationals (e.g. students and researchers, highly skilled workers, seasonal workers, members of the family, long-term residents), and for the further development of legislation and policy in this area, in particular an EU Talent Pool for third-country nationals interested in being matched with a job in the EU. The Unit is also involved in the external dimension of migration, in particular with a view to developing Talent Partnerships with key partner countries.

### WE PROPOSE

---

We propose a rewarding and challenging position of Legal and Policy Officer in a dynamic and committed team. The successful candidate will be involved in the development of legal migration policies and legislation, under the supervision of the Head of Sector for legal migration and the overall coordination of the Head of Unit. In particular, s/he will be responsible for monitoring and enforcing existing legislation in the field, carrying out analytical and interpretative work to understand the different challenges in implementation, and liaising with different actors and stakeholders, including by cooperating closely with other Commission services (e.g. DG JUST, DG EMPL and the Legal Service) and other EU institutions. S/he will also be involved in the development of new policies and legislation in this area, the steering of analytical work and studies, negotiations with the EU co-legislators when relevant, as well as the drafting of policy documents and briefings accordingly.



## **WE LOOK FOR**

---

We look for an experienced candidate with a legal background/law degree. The candidate should have proven work experience (3 years as a minimum) in EU policy-making and legislation, a keen interest in migration and legal pathways, strong coordination, analytical and drafting skills, combined with a sound political judgement. The ideal candidate should be a team player, while being able to work autonomously. Additional knowledge and/or experience in the areas of EU migration, asylum, justice, employment or social policies, as well as external relations, would be an asset. Very good command of English (written and oral) is required; knowledge of French and/or other EU languages would be an asset.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1<sup>st</sup> contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
