STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the PMO (Paymaster Office or Office for the administration and payment of individual entitlements) is to provide a high-quality and user-friendly service to beneficiaries by promptly and accurately managing, determining and paying individual rights and expenses (e.g., salaries, pensions, sickness insurance reimbursements and mission expenses).

Within the PMO, the PMO.5 unit, based in Luxembourg, is composed of three sectors: the Joint Sickness Insurance Scheme (JSIS) (001), Travel expenses (reimbursement of mission expenses and experts' and candidates' expenses) (002) and the management of the Laissez-Passer and Visas (003 – sector located in Brussels).

PMO.5.001: Sickness insurance III is responsible for the reimbursement of medical costs, the management of direct billing and the prior authorizations for the following members and their dependents.

WE PROPOSE

We propose a Contract Agent FGII position as a Medical Secretary who will be in charge of:

- Assisting and advising medical officers on JSIS procedures, rules and interpretation arrangements.
- Provide advice to other sectors on the interpretation of the comments of the medical officers and the AIPNs on some complex files.
- Processing applications for medical authorisations and their administrative follow-up.
- Providing secretarial services.
- Ensure that medical officers' mails are registered and encoded in the dedicated internal tool.
- Prepare translation requests via an internal IT tool.
- Follow up on administrative deadlines.
- Letters and mails writing in German, English and French.



- Administrative follow-up and approval of medical authorisations, requests for application of Article 72§1 of the Staff Regulations, letters, etc.
- Ensure compliance with the Medical Council's opinions, interpretation provisions and JSIS rules when dealing with the various requests for authorisation.
- Contribute to the simplification of procedures.
- Engage with the various institutions on specific features (MEPs, etc.).
- Management of JSIS communication to members for the medical authorisations sector.

The selected colleague might also be requested to work elsewhere in the PMO depending on the needs of the service. This could in particular involve contributing to the PMO's Front Office efforts, responding to phone calls and written staff questions.

WE LOOK FOR

This publication aims to fill **2** positions.

We are looking for a motivated candidate with very good organisational and collaborative skills, rigorous and with an eye for detail.

The ideal profile for the job will be:

- Eager to learn and manage internal administrative and budgetary procedures;
- Able to take initiatives and propose pragmatic solutions, to work autonomously and proactively;
- Able to work under pressure when necessary;
- Flexible with regard to new requirements and technologies;
- Multitask.

Additionally, the selected candidate should demonstrate the following personal qualities:

- Experience providing high quality customer service;
- Excellent interpersonal skills;
- Strong capacity to communicate clearly and in a structured manner both orally and in writing;
- Autonomy and pro-activity;
- Problem-solving skills.

PMO is working towards full alignment of the Joint Sickness Insurance Scheme across sites. Your functions and job content are likely to evolve as a consequence of these endeavours.

The candidates are susceptible when needed by the service to provide support to other Sectors.

The pre-selected candidates will be invited to an interview and written test soon after the closing date for application.



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

For contract agents under Article 3(a) the first contract will be 1year. The contract might be extended in the interest of the service. If a second extension of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
