STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for digital services enables, drives and supervises the Commission's digital transformation and the transformation of its IT delivery model. It ensures that the digital landscape in which we operate is robust, resilient and secure, supports digital-ready policy making across the Commission and facilitates stronger collaboration between European public administrations. DIGIT Unit R.2 Budget and Finance is a large and friendly unit of 35 colleagues. The work is interesting and varied as our three sectors are managing projects at Unit, DG and corporate level. We are responsible in DIGIT for budgeting (draft budget, programming and monitoring of execution), accounting (establishment of the financial accounts of the DG), financial transactions (financial initiation and verification of commitments, payments, recovery orders and the authorization of payments) and managing agreements (Memorandum of Understanding/Service Level Agreements). Given Directorate R strategic role in DIGIT, our Unit is also engaged in key crossunit projects.

WE PROPOSE

We propose a position as Project Manager, who will be driving, from a business perspective, IT horizontal projects in the budget and financial domains. This includes system owner responsibilities, setting of business requirements and the representation of the DG and Unit in the various stakeholders' meetings and governance bodies. The coordination and close collaboration with relevant Units of DIGIT and other DG stakeholders on various initiatives related to the modernization of the IT landscape in the budget and financial domains is a key task. The jobholder will also be part of an interdisciplinary group in charge of defining DIGIT's future IT landscape, identifying and shaping crosscutting areas. Change management and transition management are essential and challenging elements of the job.

WE LOOK FOR

We are looking for a dedicated and dynamic personality who has at least 3 years proven experience in project management and budget and financial procedures. The ability to identify and

translate business needs and requirements into technical capabilities is key. The candidate will also have an excellent knowledge of IT budget and finance tooling, ideally EC corporate landscape. Applicant will have a good understanding of the Commissions administrative budget and the Financial Regulation. Knowledge on software development lifecycle/methodologies and cost models is an asset.

ANNEX

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

ullet have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU^1

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> Decision C(2013)8970 laying down the criteria applicable to classification in step on engagement.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
