STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Office for Infrastructure and Logistics – Brussels (OIB) is responsible for facility management of the Commission buildings in Brussels and the management of social infrastructures in Brussels and at the JRC site in Ispra (Italy).

The mission of OIB is to ensure a functional, safe and comfortable workplace for Commission staff and to provide high quality support services, based on a client-oriented approach in an environmentally friendly and cost-effective way.

Within the Real Estate Department, the unit OIB.RE.1 counts about 50 staff members and fulfils two main tasks:

- The sector RE.1.001 manages space planning and manages fit-out projects and supports the Commission services with their installation or relocation.
- The sector RE.1.002 manages fit-out, construction and renovation projects as well as as-built data.

WE PROPOSE

Unit of OIB.RE.1 is seeking to hire a Project Manager.

We propose a job as Project Manager within the sector OIB.RE.1.002. The sector counts 15 people in charge of real estate projects and 4 in charge of managing the as-built data. The projects range

from small refurbishment projects within a building, to the development of an entire building of several hundred million euros.

Within the sector OIB.RE.1.002 you will be a Temporary Agent AD (Administrator).

The position consists of:

- Management of projects in all their aspects, including programming, drafting of specifications in coordination with external experts, organisation of service and works contracts, follow-up of permit applications, follow-up of the execution, commissioning, preliminary and final acceptance.
- Reporting, planning, coordination, management of budgetary and contractual aspects related to the projects involved.
- Supporting the sector with transversal tasks entrusted to him/her by the Head of Sector, whether they concern administrative aspects or technical expertise.

The position involves frequent coordination with different departments within the Office and the Commission as well as with the actors of the real estate market.

WE LOOK FOR

We are looking for a Project Manager - a dynamic and motivated colleague that fits the following requirements:

1. Required

- 5 years full-time of appropriate professional experience with real estate project management.
- Degree in engineering or equivalent.

2. Desired

- Technical skills with AutoCAD, MS Projects, MS Office.
- Knowledge of a project management methodology, an environmental certification or rating scheme, knowledge of norms, legislation, and policies in the real estate and construction domains.
- Experience in the fields of construction, building services (HVAC, MEP...) and experience with a project management methodology.

3. Personal qualities required for the position (assessed during the interview)

- Team player, client orientation, effective communication.
- Ability to set priorities, organisation and planning.
- Problem solving and methodological approach.



4. Languages

- French and English(C1)

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of English (one of the 24 official languages of the EU¹)
- AND a thorough knowledge (minimum level C1) of French (official language of the EU), to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in French and English.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

² Officials from the Commission or other Institutions are invited to use the standard channels (SYSPER or inter-institutional vacancy portal).



The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
