STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

As the corporate communication service under the responsibility of the President, DG Communication (DG COMM) promotes the political priorities of the Commission and contributes to bringing Europe closer to citizens. It keeps the Commission abreast of political developments and of trends in public opinion and the media and coordinates communication campaigns within the Commission. It takes a central role in the analysis and response to disinformation and information manipulation with regard to the EU.

Unit COMM.DG.01 supports the Director-General of DG Communication in the management of our human resources, our internal communication and in the area of data, information and knowledge management. Via its Pool Entity it also provides cross DG solutions, including hosting expert staff for the internal Task Force in charge of the response to disinformation.

WE PROPOSE

We propose the leadership position for a new team in charge of data monitoring and insight for tackling disinformation and information manipulation. The ideal candidate will also lead the work on assessing the impact of the strategic communication actions and reactions to disinformation and information manipulation.

This would include amongst other tasks:

- identify emerging trends and provide early warning of threats.
- understand how disinformation and information manipulation is distributed to key audiences and generate recommendations.
- provide support for developing and targeting messages.



The post offers the unique opportunity to contribute to shaping DG COMM's efforts in addressing disinformation and information manipulation on the EU by developing high quality methodologies for the analysis of huge data volumes.

WE LOOK FOR

We look for a highly motivated, dynamic, flexible and proactive colleague and true expert in the field.

She or he will:

- have strong expertise in the detection and analysis of disinformation and information manipulation (essential);
- have at least 5 years of practical experience preferably in a European or multinational environment in the analysis of information and data related to disinformation (essential);
- have experience in the creation of methodologies for data analysis (at least 2 years desirable);
- have the ability to work independently in a very structured way;
- have a strong interest and good overview of European policy areas and of the Commission's political and information environment;
- have the capacity to build, motivate and steer a small future team;
- have earlier experience in training others, preferably in a European or international context (desirable);
- be resilient to work under pressure and adapt to tight and changing deadlines (essential);
- have experience in coordinating complex projects or tasks (desirable);
- be a true team player who can work with staff at all levels, including briefing the senior management
- have the capacity to present complex information in an understandable way to non-expert audiences;
- have professional experience in social media activity of at least 2 years (desirable).

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Oualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
