STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

With the implementation of NextGeneratioEU, the EU became one of the largest issuers on European capital markets. The Hors Classe Adviser (HCA) provides strategic advice to the DG on the funding activities in capital markets to support a coherent market approach and an appropriate positioning of the EU as an issuer in the capital markets. The advice covers the execution of funding transactions including the related internal processes and procedures, the funding planning as well the EU's market approach and the strategic positioning of the EU in the markets. The HCA participate in internal and external committees and working groups and interacts with the different stakeholders in financial markets (banks, investors, issuers, academia), in other DGs and European bodies.

The proposed position is to support the HCA in these tasks. This includes gathering market intelligence and research on developments in financial markets and putting this into context with the needs of the EU as an issuer. The policy officer will draft presentations and notes, prepare meetings and ensure the follow-up on the tasks of the HCA.

In coordination with the Investor Relations Team (DIR E) and the Communications Team in DG BUDG the job holder will prepare outreach activities and participate in the execution.

Internally the jobholder will interact with all stakeholders involved in the funding activities (DIR E, CRO) and the DG Office. The candidate should be able to represent the HCA in internal committees and working groups.

WE PROPOSE

A unique opportunity to contribute to the development and further positioning of the EU as one of the largest issuers in European capital markets. Best practices in markets need to be adapted to the needs of the EU or new approaches will be developed to achieve favourable funding conditions for the EU while minimizing the financial risks.

The position includes contacts to a wide range of experienced stakeholders from the public and private sector in financial markets.



WE LOOK FOR

A motivated person with at least 3 years of experience in fixed income markets, preferably in the issuance and trading of bonds or related products.

The person should be able to work autonomously and be open minded, willing to develop new ideas and / or pragmatic solutions based on his/her experience in capital markets. The candidate should be able to adapt flexibly to changing priorities and new topics. S/he must be able to explain complex topics to non-experts verbally and in writing in a structured and concise way. Familiarity with Bloomberg and the MS Office tools (esp. PowerPoint and Excel) is required.

Good command of English, written and spoken.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents. All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
