## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

**DGT.A.BG.2** is one of the two units of the Bulgarian Language Department of the Directorate-General for Translation of the European Commission (DGT).

Based in Luxembourg, its mission is to provide the Commission's Directorates-General and Services with high-quality translations in Bulgarian on a wide range of subjects and policy areas, such as economic and financial affairs, internal market and trade, statistics, transport, energy, environment and climate action, agriculture and fisheries, health and food safety, etc.

Our client DGs and services include: AGRI, CLIMA, CNECT, DEFIS, DIGIT, ENER, ENV, ESTAT, FISMA, GROW, HERA, JRC, MARE, MOVE, OIL, OP, REFORM, REGIO, RTD, SANTE, SCIC, TAXUD, TRADE and the Commission Cabinets.

The Unit mainly translates from English into Bulgarian and occasionally from French or other EU languages into Bulgarian.

The Unit consists of twenty-five translators and five assistants.

#### **WE PROPOSE**

Unit DGT.A.BG.2 is seeking to recruit one *Translator* to work in a friendly, cooperative and dynamic team.

The selected candidate will translate/revise into Bulgarian, mainly from English, a large variety of text types – from legislation and technical texts to reports, letters and press releases, on a wide range of EU-related subjects corresponding to the activities of our client DGs and services.

Another important aspect of the work will be revising and evaluating of outsourced translations.

The selected candidate might also be required occasionally to perform other tasks supporting the translation process, e.g. acting as coordinator for a specific field of translation or for various translation packages.

As the DGT is known for its innovations in the field of translation technologies, the selected candidate will have the opportunity to work with advanced translation technology tools and applications.



#### **WE LOOK FOR**

We are looking for an efficient and motivated colleague who can deliver high-quality translations and revisions from English and from a second official language of the European Union into Bulgarian.

In particular, the successful candidate shall:

- hold a university degree, with Bulgarian language knowledge at mother tongue level; expert knowledge in any of the subject areas of the Unit, as described above, will be considered an advantage.
- have a thorough knowledge of English.
- be fluent in at least one more official language of the European Union (preferably French or German).
- be IT savvy; knowledge and experience with computer-assisted translation tools will be considered an advantage.
- possess resilience and the ability to work both independently and in a team, sometimes under high pressure.
- have experience in translation which will be considered an advantage.

## 1. Selection

# > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

#### Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

## Languages:

ullet have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $EU^1$ 

• AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

## What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in Bulgarian, English and possibly in another official language.



## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG IV. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 3 years.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
