STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe.

Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

The Unit ESTAT.E.3 - Transport, is part of the Directorate ESTAT.E - Sectoral and regional statistics and is responsible for the provision of transport statistics to support the European Union transport and mobility policies. Unit E3 is the leading provider of high-quality data on the transport of freight and passengers as well as on transport safety, transport infrastructure, and equipment. Transport statistics are collected for each transport mode (road, rail, aviation, maritime, inland waterways) based on statistical legal bases and agreements with reporting countries, EU Agencies, and international organisations (UNECE, ITF). Annual, quarterly, and monthly statistics are published at national and regional level to monitoring policy initiatives under the European Green Deal, such as the Sustainable and Smart Mobility strategy, Safe, Sustainable and Connected transport, Fit for 55 initiatives, etc. The Unit is also developing methodologies for new transport statistics on modal split indicators, light utility vehicles, inland waterways passengers and the use of innovative data sources for traffic and mobility indicators.

WE PROPOSE

Unit ESTAT.E.3 is seeking to hire one contract agent FG IV.

The selected candidate will primarily support the Unit's regular statistical production of transport statistics in one of the above-mentioned statistical domains. Additionally, she/he will provide support in developing transport statistics based on new data sources or national surveys in cooperation with European Agencies, policy DGs, other Eurostat production units and National Statistical Institutes. She/he will therefore coordinate and supervise existing processes and new projects to develop and improve the currently published transport statistics, developing indicators and methodologies and preparing reports of project results and publications.

WE LOOK FOR

We look for a dynamic and motivated colleague, with commitment in delivering results. The capacity to manage complex projects, coordinate internal and external stakeholders and communicate effectively orally and in writing is indispensable. The expected work will also require a good mix of strategic thinking and technical skills as well as good understanding of new technologies and statistics and managing data with IT tools for statistical production.

The candidate should have good analytical and organisational skills, the ability to work autonomously in a collaborative manner and in parallel on different projects, to perform under time constraints, to have a good sense of initiative and a strong sense of responsibility.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Oualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FII¹

• AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
