## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### **WE ARE**

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe.

Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Eurostat Unit F4 is responsible for statistics on living conditions, including income, consumption and social exclusion, as well as quality of life, health, time use, crime and gender-based violence. The unit coordinates annual and periodic household surveys on income and living conditions (European Statistics on Income and Living Conditions – EU-SILC), expenditures (Household Budget Survey – HBS), time use (Time Use Survey – TUS), health (European Health Interview Survey – EHIS) and gender-based violence (the EU survey on gender-based violence against women and other forms of inter-personal violence – EU-GBV).

## **WE PROPOSE**

There is currently one open contract FG IV agent vacancy in unit F.4 – Income and leaving conditions, Quality of life. We offer a post of statistical officer to work in the EU Statistics on Income and Living Conditions (EU-SILC) team. The statistical officer will contribute to the compliance monitoring of EU-SILC data, to development work on indicators to fulfil EU policy needs, especially in relation to the European Pillar of Social Rights as well as the Youth Guarantee, Minimum Income and Access to social protection initiatives as well as to the EU-SILC dissemination activities especially in relation to News Items and Statistics Explained articles.

The work involves frequent contacts with EU Member states and other Eurostat units.

#### **WE LOOK FOR**

We look for a dynamic and motivated colleague with a background in statistics, economy and/or socio-economic analysis, with good organisational and analytical skills and a professional experience in social statistics/sample surveys (in particular on EU-SILC statistics). Commitment and a high sense of responsibility and a team spirit are expected. Open-mindedness and creativity are also very important skills for this post. Good methodological knowledge is required. Knowledge of the methodology of national accounts and/or some familiarity with statistical softwares (preferably SAS) would be an asset. Good communication and drafting skills in English are essential, and knowledge of other Community languages is valuable.

### **HOW TO EXPRESS YOUR INTEREST?**

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order: 1. your CV 2. motivation letter 3. duly filled in application form. ## 1. Selection

## > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <a href="EPSO CAST">EPSO CAST</a> data base.

#### **Oualifications:**

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

## Languages:

have a thorough knowledge (minimum level C1) of one of the 24 official languages of the

• AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

## What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Luxembourg**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
