STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the PMO (Paymaster Office or Office for the administration and payment of individual entitlements) is to provide a high-quality and user-friendly service to beneficiaries by promptly and accurately managing, determining, and paying individual rights and expenses (e.g., salaries, pensions, sickness insurance reimbursements and mission expenses).

Unit PMO.7 Finance is responsible for the budgetary negotiation and financial and accounting management of the budgets allocated to the PMO (including the implementation of budgets managed by PMO on behalf of other DGs/Institutions/Agencies). The unit is also in charge of the authorisation of payments for salaries, pensions, unemployment and SNE's.

WE PROPOSE

We propose a CA FG II position as a Financial agent.

Working under the supervision of an official or a temporary agent, you will be in charge of accounting and financial management tasks, including the analysis and initiation of financial records. Your role will include functions such as:

- Preparation and initiation of payroll and missions' payments.
- Initiation of budgetary commitments.
- Analysis, monitoring and control of payment orders and accounting regularizations.
- Liaise with operational sections for the files under the responsibility of the team/sector
- Process financial data relating to the preparation and execution of the budget.
- Creation of legal entities and third-party files in the financial system.
- Ensure that payments are due, including certifying invoices / requests for payments 'conforme aux faits' or 'certified correct'.



- Provide the available information for audit and control by Commission services or the European Court of Auditors
- Encoding in financial and budgeting toolsand follow-up of the financial transactions (commitments, payments, recovery orders, VAT, out of-budget accounts, invoices) and of all related operations
- Prepare and finalise notes and financial correspondence.
- Use of IT management systems and databases inherent to the domain.
- Data encoding, use of standard mail, email and other types of communications with customers.
- Application of standard control and financial procedures.
- Perform administrative quality checks on files for signature, verify integrity of financial data

WE LOOK FOR

This publication aims to fill **2** positions.

The ideal profile for the job has:

- Knowledge of the financial applications such as SAP (or other equivalent enterprise financial and budgeting tool),
- Experience in initiating financial transactions (invoice payments, regularizations, budgetary commitments).
- A basic sense of accounting,
- A previous experience working with numbers.

Additionally, the selected candidate should demonstrate the following personal qualities:

- An excellent culture of service,
- Very good analytical and organizational skills,
- Very good communication oral and written, in both English and French,
- A team player contributing to team spirit and willingness to cooperate with colleagues of the unit,
- Eye for detail,
- Be able to demonstrate resilience in the day-to-day work.

The main working languages of the unit are French and English, given our close interaction with other EU Institutions, Bodies and Agencies. A thorough knowledge of French / English is required.

The candidates are susceptible when needed by the service to provide support to other Sectors.

Due to the large number of applications we receive, only pre-selected candidates will be notified. The pre-selected candidates will be invited to an interview and written test very soon after the closing date for application.



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:
 - 1. your CV 2. motivation letter 3. duly filled in application form

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the EPSO CAST data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹

• AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the** <u>Conditions of Employment of Other Servants</u>, in function group FG II. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> <u>C(2017)6760</u> laying down the criteria applicable to classification in step on engagement.

For contract agents under Article 3(a) the first contract will be 1 year. The contract might be extended in the interest of the service. If a second extension of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
