STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit FISMA.C1 is responsible for policy-making and legislative/regulatory work to ensure the transparency, integrity and efficiency of the EU's capital markets in relation to corporate reporting, audit and credit rating agencies. We also work on technical areas such as accounting standards, ethical rules for auditors and governance requirements for credit rating agencies. But our most active areas of policy-making these days are sustainability (ESG) reporting and the digitisation of company information.

Our unit contributes to the implementation of some of the Commission's key political priorities, including the European green deal, the European data strategy and the creation of a capital markets union.

Our work has an important international dimension, including liaising with counterparts from other major jurisdictions such as the US Securities and Exchange Commission, as well as European and international bodies such as the European Securities and Markets Authority, the International Accounting Standards Board (IASB), the International Sustainability Standards Board (ISSB) and the International Organization of Securities Commissions. We have extensive contacts with industry and civil society. We also manage a significant budget through which the EU provides funding to a number of European and international bodies such as the International Financial Reporting Standards Foundation.

We are a team of about 20 people, including economists, lawyers, accountants and generalists, with a good balance of younger and more experienced colleagues.

WE PROPOSE

We are looking for a colleague who would provide analysis and advice in relation to the legislative and other tasks on the above areas of activity, chief among them ESG reporting standards. The candidate will be called upon to take part in the interinstitutional negotiations and to provide input to ex-ante evaluation and ex-post evaluation of EU action taken. The official will have to engage with a very diverse range of stakeholders (NGOs, trade unions, companies), EU institutions and Member State's authorities and third country representatives.



WE LOOK FOR

The successful candidate should have at least 8 years of experience in the domain, have excellent communication and drafting skills, sound judgement, a strong team spirit, and good organizational and problem-solving skills. Ability to engage with multiple stakeholder groups is necessary and experience in negotiations, both with other EU institutions and international would be an advantage. In this regard the candidate will ideally have experience of working in the EU institutions. Knowledge and/or experience of corporate transparency and reporting and/or issues regarding sustainable finance and corporate social responsibility are required for the job, including knowledge and experience of global and international developments in sustainability reporting rules. A high degree of familiarity with European environmental reporting standards and with climate transition plans would be a definite advantage. Knowledge and experience regarding the digitalisation of data and of corporate reporting would also be an advantage. Ideally the candidate will have a high level of proficiency in English and in French.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

> Type of contract and working conditions

The place of employment will be in **Brussels**

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, in function group AD.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the 1^{st} contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
