# STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

We are the Transport Investment Unit within the Directorate for Investment, Innovative & Sustainable Transport of DG MOVE. The mission of the Directorate is to develop, coordinate, implement and monitor policies for an innovative and sustainable transport policy and related investments particularly in relation to the trans-European transport network (TEN-T) and research and innovation. The mission of the Transport Investment Unit (B2) is to ensure an appropriate level of investment in transport. The Unit is in particular responsible for the implementation of the CEF programme and of the DG MOVE involvement in the taxonomy and the policy steering of InvestEU - Sustainable Infrastructure Window. It also coordinates DG MOVE inputs concerning transport investments supported through the regional funds and contributes to DG MOVE inputs concerning the Recovery and Resilience Facility. It also ensures all necessary internal and external coordination, including with Member States, the European Investment Bank Group (EIB), National Promotional Banks and other financial institutions on financing of smart and sustainable mobility. The unit is currently composed of 14 highly motivated colleagues.

#### **WE PROPOSE**

We offer a challenging and interesting post where the policy officer will be coordinating and steering the work on sustainable finance in all aspects related to transport. This includes the work on the taxonomy, on green bonds, on blending as well as on all other instruments (like InvestEU) beyond grants provided by the different EU programmes. The colleague would contribute to the work for the next MFF. The job involves intensive interaction with other DGs (notably FISMA and ECFIN), with financial partners such as the EIB, National Promotional Banks and other financial institutions and investors, and with a large number of units in DG MOVE.



#### **WE LOOK FOR**

We are looking for a dynamic and highly motivated colleague with interest in transport policy and very good understanding of the main EU programmes supporting transport investment.

The successful candidate should possess strong coordination capacity. Negotiation, communication and networking abilities as well as drafting and presentation skills, especially in English, are essential.

Experience in the field of financing, blending operations, taxonomy, programme management, cooperation with EIB/National Promotional Banks and/or budgetary and financial matters would be an asset. Good knowledge of two EU official languages, one of them should be English.

Knowledge of French and other EU languages would be an asset. The candidate should also be a good team-player.

# 1. Selection

# > Am I eligible to apply?

# You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

# General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Qualifications:**

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

# Languages:

ullet have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $EU^1$ 

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

# What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

# 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

# Type of contract and working conditions

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
