## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

REGIO E4's mission is to assist Denmark, Ireland, Sweden and the United Kingdom to manage their cohesion policy programmes effectively and to gain maximum long-term benefit from the funds made available by the European Union. In close partnership with national and regional authorities, the unit monitors and assesses the implementation of programmes and operations and provides advice to stakeholders on relevant policy and implementation issues. The unit consists of 15 members and operates as a team, with exchange of ideas and knowledge being a key aspect of its functioning.

### WE PROPOSE

---

REGIO E4 is seeking to hire 1 programme manager. The jobholder will work on the implementation of 2021-2027 programmes under the responsibility of the unit. In addition, he/she will be also involved in the finalisation of the 2014-2020 programmes and the preparation of the corresponding closures, in particular for the UK programmes. The jobholder will have policy-related horizontal responsibilities and will be expected to act as first point of contact for the unit in these matters and to provide advice and guidance to unit members. These will include, inter alia, performing the quality review for procedures and documentation in the unit and providing advice and expertise on implementation and performance related issues and closure. The job involves processing annual reports; initiating payments; following up on audit issues that might arise for his/her programmes; attendance at annual performance meetings and monitoring committees; liaising with the national and regional authorities and stakeholders; communicating on topics related to the programmes managed; preparing briefings and presentations or dealing with queries from stakeholders and citizens.



## **WE LOOK FOR**

We are looking for an enthusiastic and committed colleague. The ideal candidate should have:

- a strong interest in and working knowledge of cohesion policy
- excellent knowledge and practical experience of internal and legislative procedures and of performance and implementation issues relating to cohesion policy
- deep knowledge and experience of closure issues. Practical involvement in the preparation of the 2014-2020 closure procedures would be a key asset
- sound knowledge of Commission financial and administrative rules
- good organisational skills and ability to prioritise between competing deadlines
- excellent English oral and written skills. Knowledge of Swedish would be a plus.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants<sup>2</sup>.

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1<sup>st</sup> contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
