STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- contract agents may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

It thus contributes to the building of the current and future European civil service. The RITD unit is in charge of research, innovation and test development. Its main mission is to keep abreast of the developments and find the most suitable tests and test methodologies for the needs of the client institutions. Coordination of a cross-unit network of psychologists and the training of Selection Boards are also part of the mandate of this unit.

WE PROPOSE

EPSO.RITD (Research Innovation and Test Development) Unit is looking for an accredited psychologist to work closely with its diverse team of psychologists, test developers, trainers and selection board managers. The ideal candidate would be responsible for researching and piloting new and innovative selection tests and methodologies and reviewing existing tests and processes. The job also involves collaborating with academia, relevant research communities and other international organisations, in addition to updating and creating new test content and methodology, including with external providers. The successful candidate could also be called on to contribute to the development of training for Selection Board members and to deliver this training. EPSO is preparing a reorganisation to take effect in Autumn 2024 which may have some impact on the affectation of this position.

WE LOOK FOR

We are looking for an accredited psychologist (in an EU Member State) to join our RITD unit. The ideal candidate would be capable of leading and coordinating in-house research and innovation projects on test content and methodology and follow closely new research in the field with academia and international organisations. This job requires: a strong research background and proven experience in innovation projects;

an excellent capacity to analyse coupled with creative and innovative problem-solving ability; excellent communication (presenting, chairing etc.) and drafting skills; good judgment, strong team spirit, organisation, sense of initiative proactive, responsible and reliable. A background in data science and proven experience in comparative statistics would be an advantage.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, only candidates selected for the next step of the selection phase will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with <u>Commission</u> <u>Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
