STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of DG REFORM is to provide and coordinate technical support to Member States for the preparation and implementation of structural reforms.

DG REFORM manages the Technical Support Instrument (TSI). The TSI is the European Commission's key tool for supporting Member States in designing and implementing growth-enhancing and inclusive reforms. The TSI has a dedicated budget and a legal framework for the provision of technical support to Member States.

Unit B2 'Governance and Public Administration': provides and coordinates technical support in the areas of central and local administration, e-government, judicial system and anti-corruption, efficient use of the European structural and investment funds issues. The Unit is also responsible for the European Commission Competence Centre for Governance and Public Administration, whose mandate is to steer and coordinate the activities of the Commission in this policy area.

WE PROPOSE

We propose Contract Agent FGIII post in charge of supporting the units of Directorate B and Unit 01 in the management of technical support projects as well as in the monitoring and preparation of contracts.

In particular, the selected candidate will provide support to policy officers and the Heads of unit in:

- The management of the contractual aspects of the technical support projects in the areas covered by Directorate B and Unit 01 and the preparation of the necessary administrative and financial documentation;
- The preparation and management of the contractual component of the contracting process for procurement, grant and indirect management agreements files, notably drafting and processing relevant notes and documentation for contracts, award decisions, amendments, re-

programming requests, requests for payment, de-commitments and closure files and certificates of completion, based on policy officers' guidance, including the registration of requests and launching of the process;

- The development and review of terms of reference of technical support projects.

The selected contract agent will fulfil the role of 'call coordinator' for grants in the e-grants system for Directorate B and Unit 01 and liaise with Directorate A to this effect.

WE LOOK FOR

We are looking for a contractual agent with five years' experience in project management and a strong background in financial management and contracting. Experience in an EU Member State administration dealing with reforms and experience in the preparation and implementation of technical support projects would be considered an advantage. Experience in one or more of the policy areas covered by Directorate B and Unit 01 would be considered strong advantage. Knowledge of EU financial regulation and contracting rules as well as of the financial management rules of the European Commission would be a strong asset.

The successful candidate should possess robust analytical skills, good communication skills, excellent drafting skills in English and good policy judgment. Experience in the design of technical support projects and in project management would be considered strong advantages.

The ideal candidate would be a committed and enthusiastic colleague with a good sense of responsibility and initiative and a "client-oriented" attitude. He/she should be service-minded, be able to prioritise and be willing to work in a challenging environment.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the **EPSO CAST** data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on
Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> $\underline{C(2017)6760}$ laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years (1+2+2+1).

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with $\underline{\text{Commission Decision C(2017)6760}}$ on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
