STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Maritime Affairs and Fisheries (DG MARE) is responsible for the development, implementation and monitoring of the Common Fisheries Policy and the development and implementation of the Integrated Maritime Policy. The DG has around 380 staff, distributed over 5 Directorates and 21 Units. The wide variety of responsibilities creates an interesting and challenging work environment. Hierarchical circuits are short, and working efforts translate into tangible results with a direct impact on the ground and on stakeholders.

Unit C3 contributes to the provision of a sound scientific basis for fisheries management under the CFP, including its external dimension by providing the analysis and advice focusing on scientific aspects of fisheries management through a long-term planning and by developing the Data Collection Framework and coordinating its implementation for all sea-basins with the Regional Units.

WE PROPOSE

A policy officer position with the task to contribute on specific files related to the implementation of the CFP in particular with regard to the ecosystem approach to fisheries management, and the implementation of existing international fisheries agreements in a bilateral context.

More specifically, the position entails:

-provision of Scientific advice: review and assess scientific advice on fish stocks and fisheries management and provide scientific and management- related support to MARE negotiators, contribute to drafting of relevant negotiating documents (background, non-papers)

-represent MARE or support MARE representation in context of (joint)scientific committees and liaise with member states and international experts on relevant scientific matters informing management decisions

-identify and coordinate EU experts for attending scientific meetings on various contexts

-contribute to studies on scientific advice -including to development of calls for tenders and proposals, reviewing/assessing studies outcome, identification and development of new studies of relevance for the field of work

-analyse, follow up and update/report on scientific developments (new methodologies in fisheries science and scientific advice, tools for fisheries and ecosystem-based management.

WE LOOK FOR

We are looking for an enthusiastic and dynamic colleague.

The ideal candidate should have:

- solid fisheries science experience in various contexts (ICES, international scientific bodies), in particular experience with the implementation of the ecosystem approach to fisheries management and demonstrable experience for the tasks
- solid experience with analysing and interpreting fisheries science in order to inform sound fisheries management measures is essential
- experience with coordinating scientific support in an international negotiations' context would be a strong asset.

We look for a team player with interpersonal and cooperation skills and the ability to take initiatives and work autonomously in the context of the team and the larger organisation. Very good coordination and communication skills (oral, written) are essential.

We seek commitment to quality of work, with readiness to work irregular hours and times, to participate in missions and with ability to meet tight deadlines.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
