STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

IDOC (Investigation and Disciplinary Office of the Commission) is a Directorate within DG HR that deals with investigations and disciplinary follow-up. It is composed of a small team of motivated, friendly and hard-working legal officers and assistants, who report directly to the Director-General.

Our mission is to ensure compliance with the Staff Regulations by conducting administrative inquiries and disciplinary proceedings in a fair, transparent and timely manner and in accordance with the rules on data protection.

WE PROPOSE

A very interesting job: you will be responsible for carrying out internal administrative inquiries, predisciplinary and disciplinary proceedings relating to the obligations applicable to Commission staff members.

The aim of administrative inquiries is to collect facts and to verify whether any obligation as laid down in the Staff Regulations has been breached. Disciplinary proceedings are opened once there is evidence that any obligation contained in the Staff Regulations has been breached, whether intentionally or through negligence. Our cases cover a wide variety of issues, including harassment, offences under national criminal law and serious misconduct in private life.

WE LOOK FOR

We are looking for a CASE HANDLER OFFICER.

The ideal profile for the job is an enthusiastic, well organized and motivated staff member, with a **solid legal background**, to join our existing multi-disciplinary team of case handlers.

Previous experience of at least 1 year in dealing with staff matters and disciplinary proceedings would be an advantage.

Our future colleague should have good people skills and the ability to:

- conduct inquiries proactively;
- propose solutions to upcoming questions;
- assist the Appointing Authority in disciplinary proceedings;
- liaise with other services including OLAF, EPPO, the Secretariat-General, the Legal Service and the Data Protection Officer;
- work autonomously as well as in a team;
- analyse complex situations;
- carry out horizontal tasks pertaining to the work of IDOC, such as outreach program activities, whistleblowing policy, etc.

A good knowledge of legal proceedings and practical aspects of investigations, as well as of the relevant staff rules on data protection, would be an advantage. The ideal candidate should have very good communication and drafting skills in **both English and French**. Knowledge of other languages would be an advantage.

The nature of the post requires a very strict attitude in relation to the protection of personal data and the constraints that this imposes on daily working life. A good capacity for teamwork, a well-developed sense of discretion, service-mindedness and a high level of integrity and ethical awareness are essential.

1. Selection

Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** Conditions of Employment of Other Servants, in function group AD.

> Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of similar competitions in the field that have been recently published or already planned. Otherwise,—recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
