## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

Unit DGT.R.2 "Budget and Finance" is in charge of the budgetary and financial procedures in DGT as well as the set up and implementation of internal control systems, both in Brussels and in Luxembourg.

Our unit:

- ensures that DGT's interests are served throughout the budget preparation procedure and that its financial operations are carried out in compliance with legal requirements and sound financial management criteria, and recorded in line with the Commission's accounting rules;

- ensures that accurate information on the management of DGT financial resources is made available to support decision-making;

- supports the implementation of effective internal control systems and contribute to the implementation of the ABM cycle within DGT.

#### **WE PROPOSE**

Unit of DGT.R2 is seeking to hire one finance and contracts officer. The position will consist of various tasks and will require you to work both independently and as part of a team.

This is a perfect position for a person who likes responsible and various tasks in the fields of budget and finance in a lively environment.

The tasks will include the following:

- Act as procurement officer for terminology files, and provide procurement check and assistance for events organised by field officers and language directorates;

- Prepare files and ensure initiation of the financial transactions (commitments and payments) in compliance with the Financial Regulation, Internal rules on budget execution and other related rules and budgetary provisions of the DG;



- assist in document management, electronic and physical filing of documents, and preparation of administrative documents as required;

- ensure administrative management of missions, conferences, and meetings for the whole DG, and assist with their financial management (analysis of files, proposals for corrections), in relevant Commission applications.

The unit can offer an excellent work-life balance and a healthy and friendly working environment.

#### WE LOOK FOR

We are looking for a finance and procurement officer, a committed and flexible team player, able to handle several files in parallel.

The ideal profile for the job is:

- minimum 1 year of experience in budget and/or finance and/or procurement and/or audit related areas,

or

- a sound understanding of at least one area as above and the willingness and ability to develop your skills;

- analytical skills;

- good communication skills, flexibility, versatility, and the ability to take initiative and work autonomously as well as being part of a team;

- good spoken and written knowledge of English is an asset
- knowledge of French is an advantage;

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

## 1. Selection

## > Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

## Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(a)/3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG III.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 3 years.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
