STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of Unit HOME.A2 is to ensure timely, accurate and credible communication on migration, security and borders: towards external stakeholders and the public at large (external communication) and inside the DG. On external communication, we support DG COMM on corporate communication and work with SPP to provide press material and support in media relations. We provide strategic advice to the DG and policy units and coordinate (with) relevant agencies and networks on communication. On internal communication, we work with the HOME Human Resources Correspondent to build a community of well-informed, motivated and engaged staff.

WE PROPOSE

The Political Reporter - Senior Communication Officer for Press and Media will be in charge of coordinating the line to take on DG HOME's policy areas. S/he will be responsible for drafting press materials as well as writing speeches, articles and media briefings for the Commissioner. S/he will be dealing with questions from the media and requests from the Spokesperson's Service (SPP) as well as monitoring relevant press and media related to Home Affairs policies (migration, border management and internal security).

WE LOOK FOR

An experienced writer with strong political communication skills and interest and background in the policy areas of DG HOME. The candidate should have excellent knowledge of the current challenges facing the European Union and the current political situation.

The candidate should be service-minded, result-oriented and a real team player able to build and maintain constructive working relationships with colleagues in DG HOME and other DGs. S/he should be able to work independently, take initiative when appropriate, and have a keen



understanding of the sensitive political issues at stake. S/he should have a structured but flexible approach to work and the ability to handle several priorities at the same time, keeping good track of multiple pending processes and issues.

The candidate should be able to communicate in a clear and structured way, including the ability to express complex contexts in an understandable way. S/he should have excellent drafting skills in the unit's main language: English. Excellent knowledge of German is also required.

Solid knowledge and prior experience in communication is required, in particular press & media. Good knowledge of the legislative context in the EU institutions as well as good knowledge of Home Affairs policies (migration, border management and internal security) would be an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited in this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority. Only in the case that no suitable candidate can be found from the afore-mentioned categories this vacancy notice is published and is open to other applicants².

The selection panel will choose a limited number of candidates for interview, based on the CV and motivation letter that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is an external candidate, s/he will be engaged as a **temporary agent under Article 2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

The recruitment grade, as well as the step in that grade, will be defined on the basis of the duration of the candidates' previous appropriate professional experience, in accordance with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

² Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
