STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit REGIO.F.2. is the geographical unit in charge of European cohesion policy in Austria, Germany and the Netherlands. The work of the unit involves the implementation of the operational programmes funded from the 'European Regional Development Fund' and the 'Just Transition Fund' in partnership with Member States and regions concerned and aims to contribute to strengthening economic and social cohesion in the European Union. As such, the colleagues are regularly in contact with the national and regional authorities and frequently travel to attend meetings and events. The unit is made up of 16 motivated colleagues and provides a mutually supportive, positive and dynamic work environment. The main languages of the unit are German and English and, to a lesser extent, Dutch.

WE PROPOSE

We are offering a position in the secretariat of the unit (which is made up of two secretaries). The position covers a wide range of secretarial and administrative tasks, including:

- provide administrative and logistical support to the unit
- ensure smooth communication, including by managing the functional mailboxes of the unit and dealing with the incoming and outgoing correspondence
- monitor the tasks and deadlines assigned to the unit, including briefing requests, inter-service consultations, parliamentary questions, access to documents requests
- provide administrative support to the desk officers in relation to missions.

The successful candidate will also deal with horizontal tasks, depending on their profile and needs of the unit.



WE LOOK FOR

We are looking for a motivated, dynamic and well-organised secretary who possesses a combination of technical and personal soft skills which are necessary to manage the unit secretariat and contribute to the smooth running of the unit. Technical skills include knowledge of the Commission's procedures and rules, experience with the relevant Commission tools, drafting skills and planning / coordination competences, and capacity to work against tight deadlines. At the same time, personal skills, including capacity to work in a team and to have a service-oriented and proactive attitude, pragmatism and flexibility, empathy, assertiveness, diplomacy, confidentiality, and a strong sense of ethics and responsibility, are equally important. An excellent level of English is required. A good working knowledge of German would be a strong asset. While not required, knowledge of Dutch would be an advantage.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, or a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language (German).

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of similar competitions in the field that have been recently published or already planned. Otherwise, recruitment will be at the level of AST/SC1. The maximum recruitment grade is AST/SC2, which may be granted based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
