STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Directorate COMP.J of DG Competition is entrusted with the enforcement of the Digital Markets Act (DMA) and Articles 101 and 102 TFEU in relation to digital platforms. The DMA is one of the first regulatory tools to regulate comprehensively the gatekeeper power of the largest digital platforms. It aims to make the markets in the digital sector fairer and more contestable. The DMA therefore complements the EU competition rules that continue to apply to this sector and will continue to be enforced by DG Competition.

Directorate COMP.J cooperates closely with Directorate COMP.C, responsible for the enforcement of EU competition rules in the sectors of electronic communications, media and the information technology industry, and with DG Communications Networks, Content and Technology (DG CONNECT). Furthermore, it cooperates with other Commission Services on policy initiatives in relation to digital platforms.

The units of the Directorate work together in a flexible network. The network allows for task-oriented resource allocation in implementing and enforcing the Digital Markets Act and antitrust rules and for agility in responding to new challenges in the sector.

We aim to fill around 10 posts of Case Handler Officers in the coming 6 months.

WE PROPOSE

A challenging and interesting position as a case handler in a friendly, positive and exciting working environment.

The enforcement of the DMA is closely coordinated with the enforcement of EU and national competition rules to ensure consistency and complementarity in the use of all instruments. The enforcement work with regard to gatekeepers includes preparing designation decisions, monitoring compliance, engaging in regulatory dialogues with the regulated companies and a wide array of third parties, conducting investigations into non-compliance, specifying compliant solutions, preparing decisions, contributing to defending decisions before the European courts,

etc. The tasks include coordinating with other services and reporting to the hierarchy, developing new procedures and improving existing processes, and contributing to the knowledge management.

The work is novel, intellectually challenging and interactive, involving frequent contacts with other DGs and national authorities. The successful candidate will get a chance to work in cutting-edge digital sectors.

We offer a flat organisational structure and a friendly and open-minded working atmosphere. Colleagues are given a high degree of autonomy in carrying out their tasks in a team-spirit environment.

WE LOOK FOR

We are looking for motivated and dynamic candidates with legal, economic, data scientist or engineering background who are good team players while at the same time able to work independently. They should have a sound understanding of digital markets. Specific experience in the application of competition law in the information technology sector or a "technical" profile as an engineer or data scientist are additional assets. Excellent analytical skills, written and oral communication skills and the ability to work under tight deadlines are of crucial importance. The candidates should moreover have a good sense of initiative and solid organisation skills. An excellent command of English is necessary.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

> Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group AD**.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the 1^{st} contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with Commission Decision C(2013)9049 on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
