In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

Unit C1's mission is to ensure the quality, reliability and availability of public information about European companies and their securities in a wide range of fields, including in particular [financial and non-financial information in corporate reports](#). This information serves to promote efficient capital markets; to ensure the stability of financial markets; to ensure that investment decisions take into account a range of environmental, social and governance matters; and, more generally, to protect the interest of members, investors and other providers of capital of limited liability companies. In addition, the transparency of European companies promotes corporate social responsibility. The principal activities of the unit include policy-making and managing legislation in the following areas:

- environmental, social and governance information by public interest entities;
- accounting requirements for both listed and non-listed companies;
- the availability and usability of regulated information for listed companies;
- [audit](#) and assurance of company reports; and
- the quality of [credit ratings](#).

To this end, Unit C1 engages with a broad range of European and international regulatory and standard-setting organisations. The unit also seeks to streamline and modernise the corporate disclosure framework by the use of modern, digital technologies to enhance the availability and usability of company information.



## **WE PROPOSE**

---

To contribute to the definition of Commission policy in respect of financial reporting and to participate in the conception, elaboration, negotiation and follow-up of harmonisation measures in the field of accounting to support the creation of a Capital Markets Union (CMU). Follow accounting developments globally, across Europe and at national level. Participate in the endorsement process of IFRS Accounting Standards.

Tasks include close cooperation with the International Accounting Standards Board (IASB) and European Financial Reporting Advisory Group (EFRAG) during the elaboration of amendments to existing reporting standards and new reporting standards, preparing and running the endorsement process for IFRS in the Commission and with the co-legislators (the Accounting Regulatory Committee, European Parliament Committees and others). Regular contacts with stakeholders from a wide range of backgrounds. Tasks also include the preparation of policy documents, background papers and legislative proposals in the field of accounting setting out Commission strategy and linking reporting and wider CMU-policy. Monitoring of the application of the Acquis Communautaire in Member States.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
