#### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

The mission of OIB is to ensure a functional, safe and comfortable workplace for Commission staff and to provide high quality support services, based on a client-oriented approach in an environmentally friendly and cost-effective way. The OIB.LS department's mission is to provide, both to the institution and its personnel, a wide range of logistic and support services that contribute to the well-being and good functioning of all Commission services. The department consists of 4 units (3 in Brussels and 1 in Ispra):

- LS.1: Historical Archives, Mail Services, Visual Design and Print
- LS.2: Transport, Mobility and Logistic Services
- LS.3: Social Infrastructure: Ispra
- LS.4: Catering

Unit LS.3 is responsible for managing social infrastructure for Commission staff and their families in Ispra – Varese (I). These infrastructures managed by the unit include the Catering Services (canteens, cafeteria, banqueting, "Saletta"), Childcare Services (crèche and afterschool facilities), temporary accommodation for new arrivals as well as a Club House. The Club House offers a catering service (restaurant and bar) whose management is the responsibility of the OIB through an external supplier.

#### **WE PROPOSE**

Unit LS.3 is seeking to hire 2 future colleagues "Waiter/Waitress - Kitchen staff - Cashier" for its Catering Sector. The position will consist of ensuring support for the preparation of meals in compliance with hygiene and quality standards in force, the distribution of meals (canteen, banqueting, cafeteria, etc.) and the function of cashier. Within unit LS.3, you will be responsible as a Contract Agent FG I of providing assistance in the preparation and distribution of meals.

#### Your main tasks will be:

- Perform a variety of meal preparation tasks in order to support cooks in cooking tasks;
- Distribute meals in a timely manner to supply the various lines of self-service, à la carte restaurant, banqueting and cafeteria distribution;
- Prepare and set up counters;



- Act as a cashier during the opening hours of the canteen/cafeteria;
- Keep the workplace clean to avoid any risk of contamination;
- Ensure the replacement of colleagues in the Catering sector.

#### **WE LOOK FOR**

We are looking for 2 future colleagues "Waiter/Waitress - Kitchen staff - Cashier" who meet the following criteria:

### 1. Required

 Professional experience of at least 2 years in the role of Waiter/Waitress, Kitchen staff and Cashier.

# 2. Desired

- Knowledge of emergency management;
- Knowledge of HACCP regulations;
- Technical skills with using kitchen equipment and logistics organization;
- Secondary education in the field of catering would be an advantage
- Additional professional experience in the field of catering could be an asset;

# 3. Personal qualities required for the position (assessed during the interview)

- Ability to organize, attention to detail and precision;
- Client orientation;
- Ability to work autonomously and in a team;
- Versatility/Flexibility and sense of initiative;

#### 4. Languages

Knowledge of Italian and/or English and/or French would be an advantage

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

# 1. Selection

# Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Oualifications:**

Successful completion of compulsory education

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- $\bullet$  have a thorough knowledge (minimum level C1) of one of the 24 official languages of the  $EU^2$
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

# > What about the selection steps?

The selection unit will shortlist candidates with the most suitable profiles and invite them for an oral interview. A selection panel will be set up to assess the best candidates.

The best candidates will be invited to participate competency tests on-site (in Ispra, lasting at least 3 days and remunerated as agency (intérimaire) staff). Participation in these tests will not automatically lead to recruitment as a contractual agent.

Due to the high number of applications we may receive, only candidates invited for an interview will be informed of the outcome.



## 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

# > Type of contract and working conditions

The place of employment will be in **Ispra**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG I.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 2 years**. The contract may be renewed in the interest of the service for a fixed period up to three times. Any further renewal will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group I must successfully complete a 6-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
