STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG CONNECT supports the digital transformation of our economy and society and conceives and implements the policies required to foster the internal market, to make Europe fit for the Digital age and to gain technological autonomy.

We are a unit of 18 friendly and committed colleagues, who are in charge of policy and law in the areas of cybersecurity and the protection of individuals' privacy on the Internet. We are responsible for a number of high-profile files in the field of cybersecurity such as the Cyber Resilience Act, the NIS2 Directive and the European Cybersecurity Certification Framework (Cybersecurity Act). Within the Commission, we are also responsible for international cyber relations and the EU Cyber Defence policy and EU NATO cooperation in the field of cybersecurity. The unit collaborates closely with the Cybersecurity Technology & Capacity Building Unit (CONNECT.H.1) and with the DG CONNECT Cyber Taskforce. The Directorate applies a team-oriented approach, encouraging a no-silo collaboration benefiting from DG CONNECT's expertise in ICT and the digital single market and bringing together teams with expertise from across its Units but also other Directorates in DG CONNECT, for example in the areas of the Internet of Things and Artificial Intelligence.

WE PROPOSE

We propose an attractive position of policy officer with a policy, technical, analytical and negotiation dimension. The job provides a great opportunity to be involved in an exciting area of high impact and importance, and to become part of our enthusiastic, driven and welcoming team. You will be following more closely aspects related to cybersecurity legislative and non-legislative instruments,



including, as relevant, the development of future policy initiatives, as well as work on implementation strategies and potentially related international aspects.

You will mainly contribute to the work relating to the NIS2 Directive, the Cyber Resilience Act (CRA), the European Cybersecurity Certification Framework (Cybersecurity Act), both implementation and considerations for future initiatives, including in view of the Commission's objective of further simplifying rules and improving the effectiveness of implementation. The assignments may also entail work on international files.

The final allocation of tasks will depend on the profile of the successful candidate. The work involves regular contacts with other Commission services, with Member States and as well as with stakeholders outside the Institutions. You would be expected to go on missions and to present our policies in conferences and events.

The unit applies a flexible approach to work. You will be encouraged to develop your skills and gain experience beyond your day-to-day scope of activity so that you can personally develop in areas of your interest and support colleagues across the unit when necessary.

WE LOOK FOR

We look for a motivated, responsible and efficient team player. The ideal candidate should have:

- a proven track-record of at least five years experience on digital-related policies, including cybersecurity dimension, from a policy making, legal, economic or technical perspective
- a good understanding of legal, technical and policy aspects of cybersecurity and digital technologies
- a very good understanding of policy design and policy objectives of horizontal cybersecurity frameworks
- experience with EU level decision-making and legislative or non-legislative procedures, in EU institutions or on files with a European dimension, is a strong asset
- oral and written communication skills in English; other languages are considered an asset
- a pro-active approach and ability to work autonomously and the capacity to lead and steer meetings and discussions
- excellent drafting skills in English and the ability to eloquently speak in public.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

 have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU²

• AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission. If recruited, candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

> Type of contract and working conditions

The place of employment will be **Brussels**

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** Conditions of Employment of Other Servants, in function group AD.

Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1**st **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
