## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

The Directorate-General for Communication, Unit COMM/A4 'Audiovisual Service'. The Unit responsible for the photo and video coverage of the President and the 26 other Members of the College, in Brussels and worldwide. The Unit provides free access to an extensive library of audiovisual material on the construction of the EU. It also provides technical support to TV and radio channels through easy access to its TV and radio studios, editing rooms and camera crews. Audiovisual material for TV channels is mainly distributed via satellite (EBS - European Broadcasting Service), whereas all other AV material (videos, photos, podcasts) is available on the AV Portal. The Unit is responsible for the daily management of EBS on behalf of all EU Institutions. Moreover, it is responsible for producing corporate videos and videos for social media. The unit also manages several corporate framework contracts for audiovisual services. The unit has four sectors, with 100+ staff, more than two thirds of whom are service providers with audiovisual technical skills. It contributes to the delivery of DG COMM's domain leadership in external communication and manages an annual budget of approximately EUR 13 million.

#### WE PROPOSE

A position of administrator – head of sector, in the "EBS/Photo service" (European Broadcasting Service) sector.

The successful candidate will be EBS editor-in-chief and responsible for the coordination of production and transmission of EU video news (via the EBS and EBS+ channels, and via online streaming on the Audiovisual Portal and social media), and the production and distribution of European Commission official photos and will organise the AV coverage of the Members of the College outside Brussels with a team of 4 colleagues as well as also dealing with the general co-ordination of EBS programming, transmission of video content provided by other EU institutions via EBS, organisation and chairing of interinstitutional editorial committees, and promotion and marketing of the EBS and photo service to the media and the public.



The successful candidate will also oversee the management of the human and financial resources of the sector as well as the management, coordination and supervision of the different contractors involved in the activities of the sector, under the supervision of the head of unit.

S/he will also draft and manage calls for tender related to the activities of the sector.

This position involves a wide range of responsibilities calling upon a combination of technical, organisational, coordination, financial and project management skills, including providing motivation and guidance of staff.

#### WE LOOK FOR

We are looking for a dynamic, resilient and motivated team player, with knowledge and expertise as a TV journalist, with a strong background in video news production, and with solid experience in team, contracts and budget management. At least 5 years' professional experience in audiovisual news production is essential.

The successful candidate will be able to be a good team leader as well as ready to take appropriate initiatives. Good relational skills and a strong sense of service are required. Solid knowledge of news production is essential. Experience in the public procurement and contract management experience is an asset. Reliability, discretion and good organisational and communication skills are necessary. S/he will demonstrate resilience, anticipation, availability, diplomacy, and quick response and delivery. A solid sense of humour is an essential qualification too for joining this dynamic and highly motivated group and fluent in both English and French. Any additional languages would be an advantage.

## 1. Selection

## > Am I eligible to apply?

### You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

## > What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be Brussels

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** <u>Conditions of Employment of Other</u> <u>Servants</u>, in function group AD.

## > Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the  $1^{st}$  contract will be of 1 to 3 years. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
