## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

HR.D.1 — The Working Conditions and Wellbeing Coordination unit is responsible for managing all aspects related to working conditions and time management, as well as developing, implementing, and coordinating the well-being policy. The unit ensures a good working atmosphere and good relations and comprises about 60 staff divided between two sectors. The Working Conditions sector brings together all the leave managers (GECOs). Their aim is to be in constant contact with our stakeholders (staff, HR correspondents in the DGs...) so that we can understand their needs and provide them with the best possible service.

#### **WE PROPOSE**

Unit HR.D.1 is seeking to hire one **Legal officer** to strengthen its expertise in the working conditions policy. Unit HR.D.1 proposes a challenging position for an experienced lawyer. You will work in a friendly working environment where the main tasks and responsibilities will be as follows: advise the unit (leave managers and appointing authority) on legal issues having to do with Staff Regulations, Commission decisions, draft legal texts pertaining to the working conditions field, including the policy on hybrid working; draw up legal opinions, documents and notes of analysis; prepare briefings and reports; analyse statistics relating to working conditions and time management any other legal matters within the unit. You will also be involved in wellbeing issues such as "Digital overload" and Work-life balance. This position combines the work of a legal officer with policy work and offers a very interesting and challenging opportunity in a dynamic working environment. The tasks are very diverse and require good interpersonal and communication skills.



#### **WE LOOK FOR**

We are looking for a **Legal Officer**: highly motivated with solid legal background and experience in EU law (prior experience in a legal unit in a EU institution or in a law firm) and good analytical and communication skills. Ideally, he/she will have a good knowledge of EU rules and Commission procedures and working conditions at the Commission. Knowledge of Staff Regulations and public service law is a key advantage. The main languages used in the unit are English and French. The candidate should be an excellent team player and work in close cooperation with the other members of the Unit. He/she should be pro-active and demonstrate the ability to communicate clearly. If you think this job matches your interests and profile, please send us your CV together with a motivation letter.

## 1. Selection

## Am I eligible to apply?

## You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Oualifications:**

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

## What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

#### 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission.

## > Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** Conditions of Employment of Other Servants, in function group AD.

#### Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents and with <u>Commission Decision C(2013)8970</u> laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
