STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Health and Food Safety (DG SANTE) aims to deliver to Europeans the peace of mind that comes with access to healthcare, safe food to eat and protection against epidemics and diseases. Our goal is to build and maintain Europe's high standards on food and feed safety, food sustainability, animal and plant health, as well as the most affordable, accessible and high-quality health systems to deliver on these expectations.

Unit SANTE.E.2 is responsible for policy and legislation concerning novel food, food improvement agents, food contact materials, contaminants in food and control on veterinary drug residues. These domains have a tangible impact on consumers' life and potentially attract a lot of political and media attention.

We work closely with other Commission services, Member States, industry, civil society organisations and third countries.

WE PROPOSE

Unit SANTE.E.2 is seeking to hire one Policy Officer.]

We propose an interesting position in our team to work on Food Contact Materials.

The team is responsible for developing and implementing legislation and policies to ensure the safety of these products.

We work in close contact with the EFSA (European Food Safety Authority), JRC, Member States experts and colleagues involved in related sectors in DG SANTE and other DGs, including engaging frequently with stakeholders and NGOs.

The new colleague will take an active role in implementing the legislation by managing applications on new substances and preparing regulations authorising these substances. Important part of the



work will also be to follow and to anticipate policy developments, with the aim to maintain a high level of food safety.

Building partnerships with other services in and outside DG SANTE on policies and legislation relevant to the Food Contact Materials files is also part of the job description.

He/She will regularly be tasked to draft notes, briefings, replies to EP questions, letters or other communication materials and handle procedures as such as requests for access to documents. He/She will also inform and advise various stakeholders on the content of the EU legislation in this area of activity.

WE LOOK FOR

We are looking for a motivated and dynamic colleague with a background in technologies, innovation and sustainability, who shows genuine drive for the position.

The candidate should have:

- excellent knowledge of and experience with EU Food Law. Knowledge and experience in the area of Food Contact Materials is an asset;
- experience in the implementation and management of food legislation;
- experience in enforcement of EU legislation is an asset;
- knowledge and experience in economic-related issues is an asset;
- experience in dealing with the European Food Safety Authority;
- experience in developing and managing studies and/or collaborating with external contractors;
- a high commitment to assure quality and accuracy and the capacity to plan and carry out tasks independently and in a flexible way;
- proven analytical skills, problem-solving and sound judgement;
- proven ability to manage stakeholder networks, involving key players from both public and private sectors;
- clear ability to communicate fluently in English both orally and in writing;
- ability to work both autonomously and in a team with diverse educational backgrounds;
- excellent oral and written communication skills in order to communicate efficiently and fluently with internal and external stakeholders and represent the European Commission in meetings and conferences.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
