STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG BUDG is committed to offer equal opportunities, foster a rich, diverse an equal and inclusive working environment.

The mission of Unit A5 is to enable the Institution to have the necessary administrative budget to achieve its political priorities, while fully respecting budgetary principles and constraints. More specifically, the Unit is responsible for carrying out all the activities related to the budgetary appropriations of heading 7 European Public Administration of the multiannual financial framework (MFF), respecting the principle of sound financial management. In addition, the Unit consolidates the requests of the DGs and services and proposes, jointly with other central services, the allocation of all the human resources of the Commission for endorsement by the Corporate Management Board and for the decision of the College.

WE PROPOSE

Unit A5 of DG BUDG is seeking to hire a Contract Agent (FG IV) to work in a team of five colleagues dealing with all aspects of human resource allocation for the Commission. This involves building excellent relations with the other Commission DGs, and the Secretariat-General and DG HR.

All colleagues in the team have a portfolio of DGs to follow. Each team member is closely involved in assessing the staffing needs of these services, and the potential to allocate staff, from the available budgets (administration, research, EU programmes, etc).

The team plays a crucial role in the preparation of the Commission's proposal for the annual budget, as well as preparing the decisions of the College on staff allocation. The team are also involved in broader reflections on human resources, for instance in the context of the multi-annual financial framework, reviews of the organisational structure, and any potential enlargement.



WE LOOK FOR

We are looking for a highly motivated team player, with good analytical and negotiation skills. It is essential to be able to communicate clearly orally and in writing. A good knowledge of EXCEL is required, and knowledge of the EU budget procedure, administrative expenditure and the human resource allocation process would be a distinct advantage. Excellent written and oral communication skills in English.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- You should send your documents in a single pdf in the following order:

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^2}$
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 years.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
