## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

FPI staff around the globe are proud of the work that they are achieving and have a strong sense of purpose and motivation. They take, and value, a high level of personal responsibility. A policy-driven approach, a focus on priorities, solutions and impact, combined with a welcoming and supporting atmosphere, are part of the service’s corporate culture. The service promotes professionalism and teamwork, encourages commitment and promotes respect. It also seeks to embed trust and fairness while prioritising effective communication at all levels.

The Service reports directly to the High Representative / Vice-President (HR/VP). The Service works in close cooperation with the other Commission services, as well as with the European External Action Service (EEAS), both in headquarters and in delegations.

Within the Service for Foreign Policy Instruments, FPI.3 manages rapid response actions in Europe, Asia and the Americas – both under the Crisis Response and Foreign Policy Needs components – of the Neighbourhood, Development and International Cooperation Instrument (NDICI-Global Europe). Thematically, the Unit leads FPI’s work on Public and Cultural Diplomacy, Disinformation as well as mine action and economic issues and global health.

It is also responsible for cooperation with High-income countries (HICs) and Public Diplomacy (in HICs as well as in China, India, Brazil, Mexico and Argentina) in its geographic area of responsibility.

The Unit works in close cooperation with the EEAS and all relevant European Commission services at headquarters as well as in EU Delegations. It acts as the EU’s first responder in situation of urgency, emerging crisis, crisis and post-crisis and in providing support to urgent foreign policy needs and opportunities in areas such as effective multilateralism, disinformation and foreign information manipulation, global health and public and cultural diplomacy.



Together with the FPI Regional Teams in Bangkok, Washington, and Vienna, the Unit collaborates closely with EU Member State agencies, international organisations, civil society and the private sector to effectively deliver on EU foreign policy commitments through conflict-sensitive and policy-driven action.

Team spirit, a strong sense of initiative and responsibility is a common feature of all unit members.

## **WE PROPOSE**

---

FPI.3 is seeking to hire an **International Relations Officer - Rapid Response Manager** for Europe and Central Asia, with a specific focus on the thematic areas of countering disinformation and promoting foresight.

The work involves coordination with Commission line DGs and the EEAS on EU policies and their projection abroad. The successful candidate will be part of a dynamic, friendly and motivated team with a strong emphasis on collaboration.

The position will consist in contributing to the development and management of timely, robust and well-grounded EU responses to top foreign policy priorities, crises and conflicts in third countries, in particular under the Crisis and Foreign Policy Needs components of NDICI Global Europe's Rapid Response Pillar.

Geographically the selected candidate will focus on the Europe and Central Asia region with an initial focus on Western Balkans and Turkey, while, thematically, the position will focus on countering disinformation and promoting foresight capabilities, including the coordination and quality management of related activities and working closely with other EU services and international actors.

## **WE LOOK FOR**

---

We look for an experienced, dynamic, reliable, well-organised **professional with substantial experience in the areas of foresight and / or countering disinformation as well as hands on experience in programme management**. The candidate should have excellent team spirit and planning and coordination skills with the ability to adjust to multiple tasks even under tight deadlines. They should be pro-active, flexible and able to organise the work independently with a strong sense of responsibility.

A positive attitude, excellent writing and communication skills, interpersonal skills and a good judgement are also essential as well as a good knowledge of EU financial and contractual procedures.

The candidate should have at least 5 years of experience of working in external action of which at least 1 year as a geographic or thematic desk officer, or in a comparable position managing the interface between policy and operational aspects in a geographic or in a thematic field, including in the domain of countering disinformation. Experience in the area of project



management in European external action of at least 1 year is desirable. Specific experience in managing a portfolio of action (policy or project management) in the realm of countering disinformation and prior experience with foresight are an advantage. An excellent knowledge of English is essential, a good knowledge of French is an asset, as is a good level of Russian, Arabic and / or Mandarin. Thematic knowledge of the Europe and Central Asia region, including in particular the Western Balkans and Turkey, as well as familiarity with strategies and approaches adopted by the EU to counter disinformation and / or promote foresight are a strong asset.

The candidate/job holder must either be a holder of a valid security clearance up to the level of "SECRET UE/EU SECRET" or be willing to undergo the national security vetting procedure (in order to be allowed to perform their job).

## HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission. Candidates will be required to undergo a security vetting that is conducted with the national administration of the Member State.

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
