STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

REGIO Unit D4 oversees the programming and implementation of European Regional Development, Cohesion and Just Transition Funds investments in Estonia, Finland, Latvia and Lithuania and helps implement the programmes in the most effective manner, in order to derive optimal long-term benefit for their regions and cities and thus reduce economic, social and territorial disparities.

We perform our mission in close partnership with other Commission services, national and regional authorities, as well as with the widest possible range of stakeholders on relevant policy and implementation issues.

Our unit counts up to 17 team members, very committed to deliver cohesion policy on the ground, serve the European Union's key priorities and support the eastern border regions most affected by aggressor countries, so as to ensure an effective 'right to stay' for citizens in the place they call home.

WE PROPOSE

We propose a stimulating and rewarding position as programme manager, with the following challenging responsibility to:

- Develop and monitor sector specific and horizontal policy areas in one or more of our member states, and providing country knowledge and regional perspectives for the European Semester exercise,
- Ensure in partnership with national, regional and local authorities, programme partners and stakeholders, the optimal implementation of several priorities under our cohesion programmes, including closure of 2014-2020 programmes, where needed, reprogramming of 2021-2027 priorities, and already meaningful needs assessment and preparation for EU

- Follow policy development of thematic field(s) via regular meetings and discussions, often at your own initiative, with REGIO horizontal units/competence centres, REGIO matrices and other Commission services, as well as via participation in workshops and conferences with other partners and stakeholders, including International financial institutions like the World Bank,
- Represent our unit at key meetings (Commission inter-service meetings, technical and monitoring committee meetings with programme partners), and various communication activities promoting information, communication, and visibility of European action across our regions.

The exact thematic field(s) falling under your portfolio will be decided upon the needs of the team and the profile/background of the successful candidate.

WE LOOK FOR

We are looking for an enthusiastic, committed colleague with:

- Good knowledge of cohesion policy, in particular regarding programme implementation
- Sound knowledge of the political and socio-economic context of the Baltic States and Finland
- A solid mix of analytical, communication and negotiation skills
- Good organisational skills and the ability to prioritise between competing deadlines
- The capacity to process information rapidly
- Proven track record as good team player and proactivity in liaising with colleagues and partners
- Excellent English oral and written linguistic competences.

As the unit needs to be able to rely on colleagues with linguistic skills matching our portfolio, the current priority is for us to secure the recruitment of a colleague with working level linguistic skills in Finnish (oral and written).

Finally, prior experience with the Commission environment, including financial and administrative rules, would be an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
