#### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

# IT Security Assistant – Security Assurance Development

#### **WE ARE**

A highly motivated team of around 75 IT experts including business analysts, security experts, developers, architects and managers. Our mission is to implement, maintain and expand mission critical IT system that support DG CLIMA's mission and program. One of the largest platforms in our portfolio is EU Emissions Trading System (EU ETS), the biggest carbon emissions trading market in the world. The EU ETS works on the 'cap and trade' principle. A cap is set on the total amount of certain greenhouse gases that can be emitted by installations covered by the system. The cap is reduced each year so the total emissions fall. Within the cap, companies receive or buy emission allowances, which they can trade with one another as needed.

The ETS operations are centralised in a single Registry, called the Union Registry. It holds accounts for more than 15,000 operators from the power sector and energy intensive industry, including the aviation sector. The national administrators in Member States manage the participants to the EU ETS and their accounts, while DG CLIMA as the Central Administrator is responsible for providing the centralised infrastructure, operating and further developing the Union Registry in a changing policy and security environment.

Unit E3 is responsible for developing and operating the Union Registry and other information systems supporting the EU ETS. We strive to offer high quality services to the Member States, while providing a highly secure infrastructure for the market players. As the Commission's ambitions grow and DG CLIMA's mandate expands, we will be implementing more and more capabilities and systems supporting the European Green Deal, Fit For 55 and other policy initiatives.



#### **WE PROPOSE**

Unit E3 of DG CLIMA is seeking to hire one IT Security Assistant. (S)he will be responsible for/ charged with:

- assist in the vulnerability management for DG CLIMA Information Systems
- assist in the security matters in DevSecOps (e.g. tools, management and tuning)
- coordinate with other stakeholders (DIGIT.S, contractors) involved in Web application security tests to ensure that requirements related to security are met
- assist in the White box security testing activities
- assist in the Threat modelling activities
- follow-up and report on the remediation of vulnerabilities
- ensure that developments follow a Secure Software Development Life Cycle (SSDLC), taking the OWASP recommendations as quideline
- provide training to development teams on SSDLC and application security subjects
- establish and maintain regular contacts and exchanges with relevant counterparts, in particular in DG DIGIT and in DG HR.DS
- report to the team leader and the unit management, inform and brief management and business units on the on-going incidents and their investigation or other potential issues.

#### **WE LOOK FOR**

We are looking for a colleague with a distinguished set of skills.

Specifically, we ideally look for an IT Security Assistant with certifications like CompTIA PenTest+, Certified Professional Ethical Hacker (CPEH), ISC2 Systems Security Certified Practitioner (SSCP) or equivalent.

The ideal candidate should count on experience in Application Security and DevSecOps practices and have at least 3 years of relevant professional experience (e.g. secure code review, pentesting, threat modelling, secrets management, code signing, scanning tool finetuning etc.). Good knowledge of AWS, Java, Spring Framework DevOps technologies and JavaScript is considered a plus.

Familiarity with the European Commission environment, including hosting infrastructure at DG DIGIT, is highly desirable.

Experience in implementing secure development principles and maintaining a security-focused mindset is valued.

Adaptability is key as the candidate navigates diverse work environments. Strong organizational and project management skills, staying updated on the latest security threats, and communication abilities are appreciated skills. The ability to think creatively and approach challenges from different perspectives is also important.

The jobholder must be able to work with a degree of autonomy but also be a good team player, possibly act as a team coordinator. (S)he must be prepared to work with tight deadlines under exceptional circumstances.

Considering the nature of the accesses and the sensitivity of the post, the jobholder shall be willing to initiate the request for an EU security clearance (upon request when joining the team, if not granted before).

#### 1. Selection

#### > Am I eligible to apply?

#### You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

#### **Qualifications:**

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, <u>or</u> a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

#### Languages:

Languages

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

#### What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.** 

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

#### 2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

#### > Type of contract and working conditions

The place of employment will be Brussels.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the** Conditions of Employment of Other Servants, in function group AST.

#### ➢ Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with  $\underline{\text{Commission Decision C(2013)9049}}$  on policies for the engagement and use of temporary agents and with  $\underline{\text{Commission Decision C(2013)8970}}$  laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new competition published or already planned in the field. If there is none, recruitment will be at the level of AST1, AST2 or AST3. The maximum recruitment grade is AST4, which may be granted under very exceptional circumstances, based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1**<sup>st</sup> **contract will be of 1 to 3 years.** The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2013)9049</u> on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
