STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The European Commission's Directorate-General for Employment, Social Affairs and Inclusion (DG EMPL) is responsible for EU policy on employment, social affairs, skills, labour mobility, inclusion, and the related EU funding programmes

Directorate C works towards promoting social dialogue and improving working conditions through effective labour law and safe and healthy working environments.

More specifically, the mission of Unit EMPL C.4, a geographical unit, is to monitor and assess employment and social policies in Spain and Malta. In this context, the Unit contributes to the implementation of the European Pillar of Social Rights and is a key actor in the European Semester process. It provides input to the annual cycle of analysis and assessment of national reform programmes and policies and the formulation and monitoring of the country specific recommendations for Spain and Malta.

The unit is also responsible for the efficient and effective programming and implementation of the European Social Fund (ESF), the ESF+, the new Just Transition Fund (JTF) and the Social Climate Fund (SCF). The aim is to support Spain and Malta in their transition and recovery and prepare them for the green and digital transitions.

WE PROPOSE

The successful candidate will assist in managing ESF programmes for Spain and cover all aspects of ESF management including monitoring of implementation, follow-up of control systems and potential irregularities, evaluation and closure. He/she will contribute to ensuring the effective application of all relevant ESF and Structural Funds Regulations, in cooperation with other services and the Member State. He/she will contribute to periodic reports on financial monitoring. He/she will also assist in monitoring social inclusion and employment policies and reforms at regional level as well as their impact on job creation and poverty reduction.



WE LOOK FOR

We are looking for a highly motivated candidate with a good sense of initiative and responsibility, being a good team player, able to quickly identifying key issues, having good drafting skills and delivering quality outputs under tight deadlines. Strong communication skills are essential.

Excellent knowledge of Spanish and English is an advantage. Working knowledge of French would be an asset. Experience and interest in programme management of Structural Funds programmes are an asset, as is knowledge about policy developments within the European Pillar of Social Rights.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

- 1. If you are not registered yet in the open EPSO database, please do so at the following address: <u>CAST Permanent</u>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.
- 2. You should send your documents in a single pdf in the following order:

1. your CV 2. completed application form.

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^1}$
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG III.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year.** Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.
