### STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### **WE ARE**

The Directorate-General for Mobility and Transport (DG MOVE) is responsible for developing and implementing European policies in the transport field. Within DG MOVE, Directorate C covers "Land transport", embracing road, road safety and all rail matters, except financing and passenger rights. Unit C4 is responsible for the technical side of rail policy by creating a smart, safe and sustainable rail transport system without frontiers and thus contributes to digitalisation and low/zero-emission policy.

The core tasks of the unit are:

- Policy development, in particular work towards a more harmonised and innovative rail system, for better and more affordable services, while ensuring railway safety and interoperability of systems;
- Identification of valid technical solutions developed by research and rail expertise and turning them into legislative and non-legislative measures ensuring that rail is fit to deliver the needs of the European Green Deal and the Smart and Sustainable Mobility Strategy;
- Management, policy instruction and monitoring of the European Union Agency for Railways (ERA) and the Joint Undertaking Europe's Rail (ERJU);
- Contributing to tasks in other DG MOVE units, such as TEN-T financing, passenger rights, multimodal digitalisation and data exchange; and
- · Close liaison with all actors in the rail and the rail supply field and with intentional partners.

### **WE PROPOSE**

The main tasks would include the coordination and overseeing of briefings, preparation of files, organization of missions and meetings (and subsequent reimbursement requests), helping to deal with legislative procedures, translation requests, launching Interservice consultations and the registration and follow-up of incoming/outgoing mail, ensuring deadlines are met etc. He/she will also coordinate the handling of complaints and infringements and requests for access to documents. The successful candidate will also work closely with the other assistant, providing back-up in her absence. DG MOVE is keen to provide assistants with good opportunities for continuous learning, enabling new colleagues to acquire the necessary skills to work autonomously, to develop initiatives and to manage their own priorities.

#### **WE LOOK FOR**

We are looking for a motivated and dynamic colleague who enjoys teamwork. The post requires reliability, accuracy and attention to detail and good organizational skills. The candidate should demonstrate a sense of initiative and willingness to assume responsibilities, as well as the ability to work both as a member of a team and independently. The candidate should have good knowledge of the standard IT tools (e.g. Word, Powerpoint, Excel) A good command of English is essential; knowledge of French would be an asset. Familiarity with tools used for Commission adoption procedures would be an additional advantage.

### **HOW TO EXPRESS YOUR INTEREST?**

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

  <a href="Permanent">Permanent</a>. Please select under selection procedures for contract agent the CAST permanent profile that best suits your education and experience.</a>

### 1. Selection

### > Am I eligible to apply?

### You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <a href="EPSO CAST">EPSO CAST</a> data base.

#### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the FU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

### What about the selection steps?

The selecting unit chooses from the EPSO database<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

### 2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

### > Type of contract and working conditions

The place of employment will be in **Brussels.** 

The successful candidate will be engaged as a **contract agent under Article 3(b) of the**<u>Conditions of Employment of Other Servants</u>, in function group FG III. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with  $\underline{\text{Commission Decision}}$   $\underline{\text{C(2017)6760}}$  laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
