STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Under the political guidance of the College of Commissioners, in particular Apostolos Tzitzikostas, Commissioner responsible for Sustainable Transport and Tourism, the Directorate-General for Mobility and Transport (DG MOVE) is responsible for developing and implementing European policies in the transport field, including the promotion of Trans-European networks and transport research policies. Directorate MOVE.B is in charge of developing, coordinating, implementing and monitoring policies for an innovative and sustainable transport policy and related investments. It consists of five units.

Unit MOVE.B.3 "Innovation & Research" is in charge of designing and implementing appropriate transport Research and Innovation (R&I) policy to foster innovation in and between all transport policies and areas and their links to related policy fields such as energy and digitalisation. Although not fully mentioned in its title, the mission of Unit B.3 is also to coordinate and implement an urban mobility policy and rural mobility links to support the transport objectives of the EU. The unit is composed of 20 staff members and it is located in Brussels.

WE PROPOSE

Unit B3 of DG MOVE is seeking to hire one colleague. The position will consist of :

- Handling complaints from citizens, in particular on urban vehicle regulations and parking
- Contributing to the implementation of the legal requirements related to urban nodes in Regulation 2024/1679 with legal expertise
- Preparing answers to questions (written and / or oral) and / or petitions from the European Parliament, investigations by the European Ombudsman and / or reports of the Court of Auditors which are relevant for the unit.
- Contributing to drafting of legal texts which are relevant for the unit
- Contributing to the development, management, monitoring and / or evaluation of policies relevant for the unit.



We offer work in a friendly and collegiate atmosphere, which will bring opportunities for the right candidate to learn and develop further in her/his career.

WE LOOK FOR

We are looking for a motivated and dynamic colleague with at least 3 years of relevant professional experience and an in-depth knowledge of European Law (legal analysis and advice). Experience in transport policy would be an asset.

He/she should be a team player, with excellent inter-personal skills and knowledge-sharing culture, proactively reaching out to cooperate with colleagues in the unit, in the DG and beyond.

The successful candidate should demonstrate his/her ability to create links between technical/legal issues and political priorities and to effectively communicate in a structured way with various stakeholders and the public, orally and in writing. He/she should be well organised and have strong problem-solving and analytical skills. For this particular post, a very good knowledge of English is required.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^2}$
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
