STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- <u>temporary agents</u> are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- <u>contract agents</u> may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG Trade and Economic Security defines, leads and implements the Union's trade and economic security policy. EU trade policy is an EU exclusive competence.

Unit TRADE.E.3 is responsible for developing and implementing the trade policies related to trade in goods, energy, customs and origin, as well as to relations with industry. The Unit is made up of 24 great colleagues, who work in a very good team spirit and is divided in three clusters: Rules of Origin, Trade in Goods including Trade Facilitation and Industry.

WE PROPOSE

We propose a Policy Officer position within our Rules of Origin team, consisting of colleagues with extensive expertise in this domain. The successful candidate will have to apply its technical expertise in this field and to manage diverse tasks, including negotiating rules of origin within Free Trade Agreements, presenting and defending the EU position in international forum. The position offers opportunities to engage with other EU Institutions, Directorates General, international organisations, Member States, and different industries.

WE LOOK FOR

We are looking for a team player with strong inter-personal and analytical skills, a sense of initiative, judgement, discretion and flexibility. The ideal candidate should have:

- A proven track record in dealing with rules of origin and customs matters in the private or public sector (minimum 3 years).
- Experience with negotiations is an asset.
- Knowledge of EU trade policy and its interplay with other policies.



- Strong analytical and organisational skills as well as a good understanding of political and institutional sensitivities.
- Strong interest in technical matters with a willingness to deepen expertise in the production processes of products. The ability to deliver quality outputs and ensure multitasking under pressure.
- Excellent capacity to work as part of a team.
- Knowledge of EU trade policy and its interplay with other policies. Ability to work in an international environment, with potential missions abroad.
- Proficiency in Microsoft Office Applications, including Excel, PowerPoint, Word, and SharePoint, along with a strong understanding of general IT technical skills.
- An excellent knowledge of written and spoken English, with excellent drafting and communication skills for both internal and external audiences, is essential.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

1. Selection

> Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST Function Group IV. At the stage of the application, it is sufficient to be registered in the <u>EPSO CAST</u> data base.

Qualifications:

(a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the $\ensuremath{\text{EU}^2}$
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

> What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical checkup carried out by the Commission.

> Type of contract and working conditions

The place of employment will be in **Brussels**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the** <u>Conditions of Employment of Other Servants</u>, **in function group FG IV.** General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with <u>Commission Decision</u> C(2017)6760 laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 year.** Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with <u>Commission Decision C(2017)6760</u> on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
